The annual loan maximums (for combined subsidized and unsubsidized loans) are \$7,500 for a Dependent student and \$12,500 for an Independent student (based on eligibility). Students enrolled in this program and requesting loan amounts greater than the above listed sophomore level **must provide a current program evaluation** (from WebAdvisor) along with this loan application.*
