RE: 2019-2021 Tentative Paving Schedule

DATE: May 15, 2019

Enclosed is a list of roads and streets that the Public Works Department is planning on paving in the next three construction seasons. The intent in providing this list is to ensure that all necessary parties, such as utilities and land owners, can plan any necessary work prior to our paving the street. This is important because the City institutes a five-year moratorium on all paving projects, regardless of scope of work.

In previous years, the list was planned based on ideal conditions, leading to a situation where we are unable to pave all the streets on the list. This year, we are publishing a list that takes into consideration other factors that impact the number of streets that we can pave in a given year. Our goal is to provide a list as accurate as possible, so this reduction does not reflect a reduced capacity, but represents the amount of work that we have performed in the past and will continue to perform moving forward, funding permitting.

Of course, it is possible that the list, especially the upcoming years, may change based on funding approvals, construction costs, coordination delays, weather, and other commitments of our crews. Streets not paved in the stated year will likely be placed on the list for the following year.

Please note that this list does not include sidewalk projects and projects that are in the CIP for a more in-depth treatment, such as reconstruction. Streets that are candidates for higher-level treatment will be submitted in the five-year CIP plan.
