#### COMMUNICATIONS:

COUNCILMEMBER STEADMAN noted that the Beautification Committee has been quite active, despite being winter. The Woodward Talk published an article with Doug Deeds featuring the greenhouse. Many projects are coming for the Committee, including planting seeds, painting hydrants, and beautifying the bus stop at 12/Woodward; the Committee wants to make the bus stop more inviting. At the Library, Lillian Greenhut retired after 45 years of service. The Library has been selected as host location for Michigan Notable Books program on June 4th at 6:30 p.m. Recently, Dr. Roy Finkbein addressed a large crowd to discuss his book, 12 Years a Slave; and the Friends of the Library had successful bake sale. She concluded by wishing everyone a Happy St. Patrick's Day.

<u>COUNCILMEMBER BLANCHARD</u> announced that there are only three days left till spring. He thanked everyone for participation in the Home Improvement Expo, and wished everyone a happy and safe St. Patrick's Day.

COUNCILMEMBER BAKER expressed thanks to the Public Safety and DPW for putting a fire lane in place along one of our streets that is a very popular location on St. Patrick's Day. Berkley has been in the news a lot lately including: Safewise named Berkley as one of the five safest cities; five our restaurants were featured in the Detroit News for fine dining, he noted that O'Mara's Restaurant is celebrating their 20th anniversary; the 2014 Michigan Green Communities Challenge recognized Berkley at Silver Level which recognized environmental leadership; the Berkley District Court scored ten percent higher than average in customer satisfaction over other District Courts in a State survey; and finally, the MEDQ awarded a \$600,000 grant for storm and sewer assessment.
