RECOGNITIONS/PRESENTATIONS

RESOLUTION NO. R-09-15: Matter of approving a resolution authorizing the Execution of the Advance Construction Contract between the City of Berkley and Michigan Department of Transportation (MDOT) for the Coolidge Resurfacing Project, MDOT Contract #14-5651. Councilmember Baker moved to approve Resolution No. R-09-15. Seconded by Mayor Pro Tem Terbrack. Ayes: Kideckel, Steadman, Terbrack, Baker, Blanchard, Edgar, and O'Dwyer Nays: None

Motion Approved.

Public Works Director Derrick Schueller gave a brief summary to the City Council to include the advance construction option, bid opening requirements and the project start date of April1, 2015 with a finished date of July 31, 2015.

City Engineer and HRC Executive Vice President, Thomas E. Biehl gave a brief summary to the City Council to include bid results, 10% to 35% base repair comparison and service life of 7 to 10 years, possibly 15 years.

City Engineer and HRC Vice President, Roland N. Alex gave a brief summary to the City Council to include the stages of traffic maintenance, base pavement information, and informing residents and businesses of the project.

Finance Director David Sabuda gave a brief summary to the City Council to include the approved \$760,000 budgeted amount at the July 2014 Council Meeting and a budget amendment for the project at the April 2015 Council Meeting.

MOTION NO. M-14-15: Matter of amending the budget for the Coolidge Resurfacing Project from \$700,000.00 to \$785,863.50. Further resolved, the City Council directs the Finance Director to bring forward the necessary budget amendment at a future Council Meeting. Councilmember Kideckel moved to approve Motion No. M-14-15.

Seconded by Councilmember Edgar. Ayes: Steadman, Terbrack, Baker, Blanchard, Edgar, Kideckel, and O'Dwyer Nays: None Motion Approved.

ORDINANCE NO. O-01-15: Second Reading, matter of adopting an ordinance to add Article XIII – Valet Parking to Chapter 30 Businesses, of the Berkley City Code to add the City's Valet Parking Rules. Councilmember Edgar moved to approve Ordinance No. O-01-15. Seconded by Councilmember Kideckel. Ayes: Terbrack, Baker, Blanchard, Edgar, Kideckel, Steadman, and O'Dwyer Nays: None Motion Approved.

City Manager Jane Bais-DiSessa informed the City Council she has spoken with Vinsetta Garage to discuss items of concern and to be addressed by Administration.

City Attorney Dan Christ gave a brief summary to the City Council to include policy issues to take under advisement over a period of time, draft ordinance does not have a three strike provision and the ordinance will take effect 30 days after the first publication.

Curt Catallo, owner of Vinsetta Garage and Car Bar, expressed his concerns to the City Council to include valet parking comparison with City of Royal Oak and City of Birmingham, the 2007 master plan and valet parking ordinance being prohibitive.

MOTION NO. M-15-15: Matter of authorizing the City Manager to execute a contract with Kelly Lawn Service to serve as the City's grass and weed cutting contractor.

Councilmember Steadman moved to approve Motion No. M-15-15.

Seconded by Councilmember Kideckel.

City Planner Amy Vansen gave a brief summary to the City Council to include Kelly Lawn Service was the sole bidder, there was a modest increase in price, and the contract is renewed every three years.

RESOLUTION NO. R-10-15: Matter of adopting the Oakland County Hazard Mitigation Plan. Councilmember Blanchard moved to approve Resolution No. R-10-15. Seconded by Councilmember Egar. Ayes: Blanchard, Edgar, Kideckel, Steadman, Terbrack, Baker, and O'Dwyer Nays: None Motion Approved.

City Manager Jane Bais-DiSessa gave a brief summary to the City Council to include the requirement for federal compliance, funding relief from natural disaster, and introduced Michael Pousak of the Oakland County Homeland Security Division. Ms. Bais-DiSessa informed the residents that the city website has information on hurricanes, floods, and training opportunities through Oakland County.

Emergency Management Coordinator from Oakland County Homeland Security Division, Micheal Pousak gave a brief summary to the City Council to include the 2012 CTV (City, Township, Villages) adopted by the communities in Oakland County, the Berkley School District is covered under the local plan that is updated every five years, qualify for grants through the State of Michigan, and trainings are done by individual municipalities such as the Emergency Management Courses.

Public Safety Director Rick Eshman gave an example of a hazmat situation in July 2012 there was a gasoline spill at the Oak Park Marathon located at 11 Mile Road and Greenfield Road.

Public Safety Director Rick Eshman gave a brief summary to the City Council to include the bid result, the correct spelling of company name is First Due Fire Supply, and the proper disposal of expired gear.

Mayor Pro Tem Terbrack reminded everyone of Opening Day for Detroit Tigers is Monday, April 6th.

COUNCILMEMBER BAKER: updated everyone on the DDA meeting on Wednesday, March 11th which presented and passed their budget process with the upcoming year's projects. He invited everyone to the "Bowl for Kids' Sake" fundraiser event at Hartfield Lanes, benefiting the Big Brothers Big Sisters program. The Fifties Theme event is hosted by DTE and Strategic Staffing Solutions.
