CITIZENS COMMENTS

City Clerk Phommady A. Boucher gave an Oath of Office to Public Safety Officer Brian D. Gothard.

Public Safety Director Richard M. Eshman spoke about Officer Brian Gothard's career of 23 years with the Royal Oak Fire Department as a Firefighter and Paramedic; where he rose to the rank of Lieutenant. Officer Gothard retired early from the Royal Oak Fire Department and was hired with the Berkley Public Safety Department in September 2015. He was schedule to attend the Police Academy in January 2016, but was diagnosed with acute myeloid leukemia in December 2015. Officer Gothard received treatment for 6 months then in July 2016 he was declared cancer free and fit for duty. In the past year, he has demonstrated a different type of courage while battling cancer. At the hospital when the outlook was grim; he always greeted everyone with a smile and an unbelievable sense of humor. His only expressed concerns were for his family. He constantly apologized for not being available or able to share the work load in the Public Safety Department. Brian wanted to share his experience and be an example for others in similar circumstances, show them there is hope and to encourage them to keep fighting. The Public Safety Department is very fortune to have a person with his character, courage, determination, and consideration for other people. He would make an outstanding Public Safety Officer.

Public Safety Officer Brian D. Gothard thanked council for the honor and recognition. He introduced his wife Sarah, his daughters Lauren and Ainsly and he expressed his appreciation for all their support.
