CITIZENS COMMENTS

Paul Jordan, Berkley resident at 3990 Tyler, suggest that the sound system in the Council Chambers be included in the building assessment and expressed his concerns in regards to the increased number of new builds in the city. He inquired about the liability to the city if any injuries were to occur at the construction sites that block the sidewalk.

RECOGNITIONS/PRESENTATIONS:

Councilmember Steadman read Resolution No. R-31-16 into record.

Annette Majka spoke on behalf of the retirees, that they all enjoyed the many years of working in Berkley and especially at the Public Library.

Library Director Matt Church expressed his gratitude of working with each retiree at the Berkley Public Library. He recognized them for their number of years of dedication to the library and the community.

Councilmember Graveline read Resolution No. R-32-16 into record.

Councilmember Terbrack read Resolution No. R-33-16 into record.

<u>PRESENTATION:</u> Matter of receiving a presentation by the Regional Transportation Authority of Southeast Michigan (RTA) regarding the RTA Regional Transit Master Plan.

Mayor Pro Tem Baker moved to receive the presentation regarding the RTA Regional Transit Master Plan. Seconded by Councilmember Terbrack.

City Manager Baumgarten introduced Planning and Financial Analysis Manager for Regional Transportation Authority (RTA) Ben Stupka.

The Regional Transportation Authority of Southeast Michigan (RTA) gave a PowerPoint presentation that included existing transit network is the foundation, bus rapid transit, regional rail, cross-county connectors, commuter express, local service, airport express, and streetcar. Mr. Stupka informed council for a home that has an assessed value of \$200,000 and taxable value of \$100,000 will cost an average homeowner \$120 per year and the average taxable value in the region is around \$72,000. Viable evidence has shown that property values and economic development has increased in areas that have a

rapid transit project. Mr. Stupka affirmed that there will be a direct route to downtown Detroit. He encourages anyone interested to visit RTAMichigan.org for the financial information and Master Plan details.

Mayor Pro Tem Baker asked Mr. Stupka to give an estimated tax cost for an average homeowner annually for the RTA proposal, explain how this project may increase the property value, and affirm the route to downtown Detroit.

COUNCILMEMBER GRAVELINE: gave an update that there have been 111 new tree orders, the Tree Board is seeking new members, and she welcomes Lisa Fritsch as a new member of the Tree Board. The next Planning Commission meeting is scheduled for Tuesday, September 27th at 7:30 p.m. and they will be reviewing the results from the Open House

COUNCILMEMBER TERBRACK: invites everyone to participate in the following Parks and Recreation programs: "Tale on the Trail" at Tot Lot on Monday, September 26th at 6 p.m.; the Ice Arena now has open skating and open hockey, please contact the Parks and Recreation Department for available times;

"Robina Plaza - Picnic Lunch" on Wednesday, September 21st from 12 noon to 2 p.m.; and "Robina Plaza - Summer in September" on Saturday, September 24th from 12 noon to 3 p.m. Councilmember Terbrack thanked Scott Jennex and the Parks and Recreation staff for another fantastic summer program.

MAYOR PRO TEM BAKER: gave an update from the Michigan Municipal league (MML) Annual Conference that includes the website www.savemicity.org which provides information about state shared revenue. Across the country from 2002-2015, on average a 50% growth of revenue passed through the states to the local municipalities, only 49 out of 50 States in the nation benefited from that increase. Michigan was the only state that did not invest the money into its local municipality but has given 8% less back to the communities since 2002. \$7.5 Billion has been redirected from the municipalities back to the state and \$5 million in funding was kept from City of Berkley alone; this is an estimate of \$500,000 per year. Mayor Pro Tem Baker encourages everyone to visit www.savemicity.org and talk to their representatives regarding local municipality funding. He concluded with a quote from speaker and author Brian Solis, "Community is much more than belonging to something; it's about doing something together that makes belonging matter." The Downtown Development Authority is thankful for the feedback from the residents and businesses about the Robina Plaza project. It is "Childhood Cancer Awareness" for the month of September and there may be gold ribbons decorated around the city for the cause. In Berkley, Laila Laqua who was diagnosed with a rare form of Leukemia at 10 months old is a full time resident at Beaumont Hospital; she receives support from the facility, family, and neighbors. The family has setup a page titled Lagua Strong at www.gofundme.com and at www.caringbridge.org

COUNCILMEMBER STEADMAN: thanked Library Director Matt Church for his annual report presentation and for all his hard work at the Library. She encourages residents to apply to the Beautification Advisory Committee; they are seeking new members. Councilmember Steadman gave a brief update from the Michigan Municipal League (MML) Annual Conference on the following legislative issues: Tax Increment Financing (TIF); Dark Stores; Infrastructure, Protecting Public Health and Safety-working with the Department of Environmental Quality (DEQ); Personal Property Tax Changes; Reimbursements; and Freedom of Information Act (FOIA). She spoke briefly about the following active issues: Medical Marijuana; Brownfields - Clean Energy and Clean Water; Tax Exemption for Non-profits; Road Warranties; Speed Limits; Autonomous Vehicles; Local Cost Sharing; and Michigan Department of Transportation (MDOT) Road Projects. Councilmember Steadman briefly mentioned upcoming issues: Telcom Line Relocation; Historic Districts; Billboards; Fireworks; the Gag Order; State Budget; and Revenue Sharing. She encourages everyone to visit the website www.savemicity.org

COUNCILMEMBER BLANCHARD: invites everyone to the Public Safety Fire Open House on Saturday, September 24th from 1 p.m. to 5 p.m. There will be activities for the kids, training, and a smoke house. Councilmember Blanchard shared a quote from an Unknown Author, "Volunteering is the ultimate exercise in democracy. You vote in election once a year, but when you volunteer, you vote every day about the kind of community you want to live in."

CITY MANAGER BAUMGARTEN: gave a brief update to remedy a previous builder complaint and flooding on a residential property next door to a construction site. He invites everyone to the Robina Road Closure Kickoff with the "Robina Plaza - Picnic Lunch" on Wednesday, September 21st from 12 noon to 2 p.m. The Downtown Development Authority (DDA) is the funding vehicle for the Robina Plaza Project. City Manager Baumgarten invites everyone to the "Robina Plaza - Summer in September" on Saturday, September 24th from 12 noon to 3 p.m.

CITY ATTORNEY STARAN: gave an update that the Senate and State House have recently passed bills regarding medical marijuana that are on the Governor's desk for signature. This proposal will include state licensing, taxes, annual permit, and ordinances to be created by local municipalities. The proposal will clarify the law for edible marijuana products for medical purpose and tracking system from seed to sale by a committee of a five member board created by the Governor.

MAYOR O'DWYER: spoke briefly about the Berkley Area Chamber of Commerce 6th Annual MetroSold Golf Outing on Friday, September 16th at the Rackham Golf Course in Huntington Woods. Money raised went towards the Berkley Lights Parade and the Tri-Community Coalition. Mayor O'Dwyer commented briefly about the County Oakland Irish Fest on Saturday, September 10th; he thanked former Councilmember Dale Goodcourage and Stephen Zannetti for a successful event. Mayor O'Dwyer reiterated the findings from Mayor Pro Tem Baker in reference to Michigan being the only state that did not reinvest money into its local municipality and has given 8% less back to the communities since 2002. \$7.5 Billion has been redirected from the municipalities back to the state and \$5 million in funding was kept from City of Berkley alone; this is an estimate of \$500,000 per year. Mayor O'Dwyer reminded the audience that the council will now adjourn the regular meeting to close sessions and when they return from close session there will be no further business beyond that.
