
On September 22nd Brighton Fire hosted its Annual Open House and Pancake Breakfast at all five fire stations.

Calls and Events of Significant Importance:

• On September 13th, units responded to a two vehicle, high speed accident reported at I-76 and Sable Blvd. On arrival, crews found a T-bone accident in the intersection of Sable Blvd and the WB Off ramp with heavy damage to both vehicles and one party trapped. The trapped party was quickly extricated by the initial arriving crew and both parties involved were transported with only minor injuries being reported

Special Operations

- We hosted a training session for the Crew Sense program at the City of Brighton Computer labs. The training session allowed users to gain more experience and ask questions with the various functions and capabilities the program offers. Chief Bodane, Chief Schuppe, BC Lutz, Rita Saunders and Andria Koenig along with members from outside fire departments attended.

Vehicle & Facility Maintenance

Facility Activities:

- Station 54
 - Engine bay door sprocket broke, not allowing operation of the door. Had new one installed and set up.
- Station 55
 - Had Psi issues with the water in the station. Had two companies come out and troubleshoot issues. Both well companies agreed that the issues was a weak pump. Pump was pulled and verified, as they were pulling the pump they also discovered several sections of pipe that were pitted and leaking. Decision was made to replace all the pipe while the pump was out. New pump was installed and set up. GNC water well had discovered that the safety for the pump wasn't working, allowing the pump to run even when it was low on water and sucking air. This is what caused the pump to become week.

Fleet Activities:


- Engine 52
 - Crews reported white smoke and check engine light, had them immediately shut down and swap to reserve. Checked al fluids, found the coolant was extremely low, now visual leaks, and no water in the oil. After getting it back to the shop, pressure tested the system, found that the EGR cooler had failed. This allowed coolant to enter the exhaust system as well as the combustion chamber and threw the turbo and on down the line. Replaced the EGR cooler and ran to test.
 - \circ Flip and rotate steer tires
- Brush 52
 - While on a call, crew stated that once they got on scene the lights were dim and truck wasn't running well, soon after it had died. They had to jump it to start and drove it back to the station. Found that both alternators had failed and wasn't charging the batteries. Replaced both, charged batteries and placed back in service
- SAM51
 - Kussmaul failed, removed to send in for repairs, installed new one.
- Truck 53
 - Finished up ladder service, and water way seals.
 - #2 discharge broke at the threads, after inspection we found that corrosion was the main cause. New parts were ordered.
- Tender 53
 - Rear fill valve not actuating, removed air cylinder and rebuild. O-rings were bad.
- Brush54
 - Power to pump and rear body working erratic, sometimes wont power up at all, after troubleshooting, found that the master switch to the body was bad, not making complete connections. Installed new master switch to resolve the issue.
- E55
 - Discharge pressure relief valve not working 100%. Valve cracks open but will not recirculate enough to do its job. Check for plugged lines, pulled valve out and checked seals and o-rings. Found that the master drain valve was bad internally allowing water pressure to back feed to the relief valve and not letting it open to by-pass water. Plugged the line from the master drain temporarily until a new master drain arrives.
 - Complete PM, installed new drive tires, and rebuild #2 discharge valve.
- Tender 54


• Write up of a water leak at the pump, after inspection we noticed that a lot of the plumbing is corroded and brittle, including a portion of the pump housing. Replaced 2- 2" nipples and welded a spot on the pump discharge.

Annual aerial and ground ladder test were complete, no out of service issues. The only items that were noted was on several ground ladders having sign of wear/rubbing, from being in a compartment or on a rack.






Had planned to incorporate G suite rollout into exercise and start to identify potential gaps in using these features in coordinating with Fire district and outside partners, however, rollout has been delayed so will be focused on incorporating capabilities in 2019

Eagleview Adult Center Generator Wiring Project- Currently RFP has been released and is open for bid with Denver

Brighton CERT- Final, graduation exercise to be held at Vestas training Facility on Nov 10th. Brighton Fire and PD to assist with Transfer of Command. CERT team is identifying training and equipment needs for 2019

<u>Cyber Security planning</u>- City and Fire IT, in coordination with OEM, attending a series of discussions regarding cyber security annex development and planning. OEM has customized a regional (DRAFT) response template with local information and will be reviewing and utilizing in Aug 15th TTX to discuss City Cyber Security incident planning template and the Situation Manual designed for scenario.

Debris Management/Damage Assessment/RNA Plans- working with recovery committee and Adams County on assessing current plans and developing local plans to fill gaps and coordination.

2018-2019 THIRA/ Capability Assessment updates- Brighton OEM participated workshops to support the development to f a regional THIRA document which will guide future funding initiatives. Results of regional workshop activates have not been shared. State is currently conducting similar efforts to capture state perspectives

Sheltering/Mass Care-

Committee is coordinating regionally to assess existing resources available in the region to support all sheltering operations

Also coordinating with several groups to potentially offer a legal seminar addressing the laws and nuances around service/support animals in emergencies and in shelter operations.
