To ensure the future of the Fair/Event Center, the willingness to explore new ideas, events and fundraisers is a priority. The recruitment and retention of volunteers is equally as important. Currently funds for repairs, maintenance and any improvements are donated largely by the Curry Fair Friends. The numerous events held at the Fairgrounds/Event Center, including the County Fair, depend almost entirely on local volunteers. With the pool of volunteers declining each year, recruiting new volunteers will be more of a challenge. Without the continued support of its volunteers and the thousands of hours donated, there would be no Fair, no events, resulting in no funds to maintain the Fairgrounds

#### Describe your previous experience in this appointed position or a similar position:

I retired from the Shasta Co. Sheriff's Office after 20 years, 16 of those years as their HR person. Being a new position within the Dept. I was able to assist in developing the duties and responsibilities of the position. With I the assistance of our SWAT team, I was able to create and implement a physical agility test for new deputies and correctional officers; to solve 1 retention issue, I introduced 1 additional step in the intense hiring process, a required division tour; I initiated and managed a background unit, eventually increasing to 12 background investigators. Responsibilities also included interpreting Dept. and County policies/procedures, recruitment, testing, and acting as the liaison to the County Personnel Manager.


