Please correct the 2017/2018 budget to reflect this grant, which was awarded in 2016 but not used until this fiscal year:

Grant #31363 is a supplemental STF grant awarded for the fiscal years 2016-2018 for \$55,550. This grant was in two parts:

Bus Match, \$44,250, no match needed. This was partially used on 10/31/2017 for \$8,535 for match for a bus purchase. When originally applied for we had asked for three buses, but were only awarded one.

Bus Shelter, \$11,300, no match needed. This will be used by June 30, 2018 to purchase one bus shelter for Gold Beach and to partially pay for a second shelter for Port Orford. The balance will be paid by Curry Public Transit.
