Discussion Summary:

- Gordon reminded everyone about upcoming awareness campaigns during June is PTSD, July is bereaved, August is Overdose, Septemeber is Suicide Awareness, October is Bullying, November is Tolerance and December is reflection. He asked for letters, stories and speeches in support of the monthly campaign by the 15th of each month.
- Katrina asked if their was a suicide policy at the county level? at the state level aside from the State Health Improvement Plan? Gordon said there was not currently one at the county level. Oregon state utilizes <u>Addies Act</u> (SB52) wich requires 197 Oregon School Districts to develop comprehensive Student Suicide Prevention Plans. Gordon indicated that most school districts did not meet the July 1, 2020 implementation deadline. Katrina suggested the council create a county suicide plan, Beth agreed that it would be a good idea to create a framework for a county suicide plan and present it to the BOC.
- Gordon also expressed concern with the crisis hotline during the upcoming acquisition of Curry Public Health by Oregon Health Authority. Nancy indicated that OHA is actively working with CCH to provide crisis lines and mental health.
- Council discussed moving the "Table of Hope" forward for future events and adjusting the proposed budget. The cost of a high quality wrap around tent with a custom logo would be closer to \$1500 which would use our entire United Way grant funded budget. Council agreed to do a little more price shopping and submit a revised/updated budget.
- Gordon recommended that the council talk to county legal to see about moving the youth ambassador position to a July 1 to June 30 (school year) to be more inclusive of student schedules. Katrina asked if students other than those enrolled in public school were eligible to apply. Jordan would like to see high school students get credit for participation on the council. Beth suggested an exit interview with students. Gordon also reminded everyone that Tim Wilson has retired and that the Youth Educator position is open.
