**Final Ballot Title** The following is the final ballot title of the measure to be submitted to the city's voters. The ballot title notice has been published and the ballot title challenge process has been completed.

SEVEN YEAR CAPITAL PROJECTS LOCAL OPTION FIRE EQUIPMENT LEVY.

**Question** 20 words which plainly phrases the chief purpose of the measure.

Shall Gold Beach impose \$60,000 per year for seven years for capital projects beginning in fiscal year 2022-2023? This measure may cause property taxes to increase more than three percent.

**Summary** 175 words which concisely and impartially summarizes the measure and its major effect.

This measure would impose property taxes of \$60,000 per year for seven years to purchase fire capital equipment for the City of Gold Beach. Type 1 fire engines average a useful life of approximately twenty-five years. New Type 1, Type 3, or Type 6 engines currently cost between \$425,000 and \$800,000. The Gold Beach-Wedderburn Rural Fire Protection District, to which the City provides contract fire protection services, will contribute \$100,000 toward the capital equipment. The total amount to be raised by this local option tax is \$420,000. It is estimated that the proposed tax will result in a rate of \$0.25 per \$1,000 of assessed value. The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor at the time of the estimate and may reflect the impact of early payment discounts, compression and the collection rate.
