NOTICE OF REQUEST FOR YOUR RESPONSE TO A SPECIFIC LAND USE PROPOSAL BY ADMINISTRATIVE ACTION

I. LAND USE ACTION

Application AD-2123

Type of Land Use Action: A request for a conditional use approval to reside in a Recreational Vehicle during construction of a single-family dwelling on a 7.98-acre parcel zoned Residential-Two (R2). The request will be the subject of an Administrative Decision under the authority granted by Section 2.060 (1), and in accordance with the procedural requirements of Sections 2.090, 2.100 and 2.110 of the Curry County Zoning Ordinance (CCZO).

Nature of Use Which Could Be Authorized: Use of a Recreational Vehicle as a temporary residence during the construction of a single-family dwelling.
