# Historical Data

## Statehood of Michigan

Congressional recognition of Michigan as a state in the union was delayed by a dispute with Ohio about Michigan's southern boundary. In 1838, the people of Michigan adopted a state constitution and elected a complete set of state officers with Stevens T. Mason as Governor. Later, this constitution of 1835 was accepted by Congress without re-adoption. The original delegate was seated in Congress with re-election after the formal recognition of the State by Congress (January 26, 1837).

The boundary question was settled in 1837 in favor of Ohio, when Michigan acquired the Upper Peninsula, then but little known, as compensation for the loss of the south.

## **Brief History of Organization of Saginaw County**

### Saginaw Township

For a period extending over four years between 1831 and 1835, the district known as the County of Saginaw formed a township attached to Oakland County for judicial purposes.

The Legislative Council of the Territory ordained that – “all that part of the country lying within the limits of the County of Saginaw therefore set off and established as the County of Saginaw, be and the same hereby be set off into a separate township and the name thereof shall be Saginaw. The first township meeting to be held in such township shall be held at the Fort of Saginaw, on the first Monday in April, which will be in the year 1831.”

This act was approved July 12, 1830, and came into force in 1831, when Gardner D. Williams was elected supervisor.

The name Saginaw is derived from the language of the Chippewa Indians and it means Land of the Sauks. The entire Saginaw Valley was inhabited by the warlike Sauks. However, around the year 1520, the Chippewas invaded the territory in great force, and in a series of battles, the Sauks were virtually annihilated. The bloodiest of these battles was fought on what has since been known as Skull Island in the Saginaw River and on a bluff on the Flint River about a mile from the present Village of Flushing.

### Saginaw Becomes a County

The boundaries of the County of Saginaw were set by proclamation of Governor Cass on September 10, 1822. These boundaries were subsequently changed by an act of the Legislative Council, approved March 2, 1831.

During 1834, the question of conferring on the township of Saginaw the status of a county was discussed and a resolution of the Council passed to the effect – “That the County of Saginaw shall be organized when this act takes effect.” This act of organization was approved January 28, 1835, and put into force the second Monday of February 1835.

## **First Trading Post**

Louis Campau established a Trading Post on the west bank of the Saginaw River in 1816, which he maintained until 1826, when he left and settled in Grand Rapids.

## **Treaty of Saginaw**

General Lewis Cass, representing the President of the United States, concluded the Treaty of Saginaw with the Chippewa Indians. In it the Indians ceded to the United States Government thousands of acres of land, including all the land encompassed by the boundaries of the County of Saginaw.

All preparations had been made in advance for the Council, and for many days, the Indians had been gathering at the site prepared. General Cass arrived with his staff of interpreters and assistants at the Campau Trading Post on September 10, 1819, and the Council with the Indians lasted until September

24, 1819, on which latter date the terms of the treaty were agreed to and signed. The treaty was signed by General Cass for the United States Government, and by 115 Chiefs and Warriors of the Chippewa Nation of Indians.

The site on which the Council was held is what is now the corner of Throop and North Hamilton Streets, in the City of Saginaw. The spot is now marked by a boulder and plaque erected in 1916 by the Daughters of the American Revolution and the City Federation of Women's Clubs.

## **General Information**

Saginaw County contains 3 cities, 27 townships and 5 incorporated villages. The population of the County according to the Federal Census of 2010 is 200,169 with the City of Saginaw counting 51,508 people.

Saginaw County has thousands of acres of rich, fertile soil. It is one of the leading producers of sugar beets and dry beans in the nation. The major employers of the County include: Covenant Health Care, Nexteer Automotive, St. Mary's of Michigan Health Care, Hemlock Semiconductor/Dow Corning Corp, Morley Companies, Meijer Stores, Saginaw Public Schools and Saginaw Valley State University. Saginaw County employs approximately 660 full-time and part-time personnel and has a 2012 total operating budget of approximately \$161,000,000. The equalized value is \$ 5,405,339,013 and the taxable value is \$150,454,069.

The average annual temperature is 49 degrees and average rainfall is 29 inches. Average winter temperature is 24 degrees with snowfall average of 36 inches. Summer averages 70 degrees with the hottest month of July.

The County has 13 public school districts K-12 encompassing 14 high schools. There are 3 non-public high schools and 6 public school academies. The Saginaw Intermediate School District maintains Hartley Outdoor Education Center and the special education services at the Melvin G. Millet Learning Center, Saginaw Transitions Academy, Great Lakes' Early College, Head Start and Early Start programs. Saginaw County is also home to Delta Community College and Saginaw Valley State University.

There are many cultural institutions in Saginaw County such as the Saginaw County Historical Museum, Saginaw Symphony, Saginaw Choral Society, Saginaw Art Museum, Saginaw Children's Zoo, Saginaw Children's Museum, Pit and Balcony Playhouse, the Temple Theater and the Dow Event Center. These organizations and venues host many local events, which offer quality of life experiences in the area.

### **Board of Commissioners**

The first record in possession of the County Clerk of Saginaw is dated the second Tuesday in October 1835. The first meeting was held in the home of E. N. Davenport on Friday, October 23, 1835.

The County Board of Commissioners is the governing body exercising legislative and executive functions for the County. After each Federal census every 10 years, the County Apportionment Board consisting of the clerk, treasurer, prosecutor and the chairs of the Republican and Democratic Parties of the County, meet to determine the number and boundaries of Commission districts for the next 10-year period. Saginaw County has 11 Commission Districts each representing approximately 18,000 people.

The Board has monthly general meetings usually the 3rd Tuesday of the month at 5:00 p.m. Commissioners are assigned to committees, which also meet on a monthly schedule. The Chairperson of the Board is elected by the commissioners at their Organizational Meeting the first business day of every odd year. The County Clerk is clerk of the Board. The County Board of Commissioners oversees the County budget.

The County Board of Commissioners hires a County Controller to carry out the day-to-day operations of the County and gather information for the Board on issues and the budget.

### **County Elected Officials**

There are 6 county elected officials whose statutory duties are prescribed by State Laws and the Constitution. These officials administer their offices and employees utilizing the budget set by the Board of Commissioners.

**County Clerk:** This official administers 3 divisions in Saginaw County: vital records, circuit court records and elections. The clerk is the clerk of the Board of Commissioners and serves on many other County Boards.

**Prosecutor:** This is the chief law enforcement officer in the county who represents the people in criminal cases in the local courts.

**Treasurer:** This official receives taxes and other monies due to the county, pays all of the county's bills and accounts, and invests the county's monies. The Saginaw County Land Bank is located in this office.

**Sheriff:** The Sheriff is in charge of the county jail and is the county's chief law enforcement officer. This official oversees the road patrol unit also.

**Register of Deeds:** This is the official record keeper of all real property transactions in the County.

**Public Works Commissioner:** This official is sometimes called the Drain Commissioner who operates and repairs all the county drains.

## **Courts**

A Circuit Court was established in Saginaw County on February 12, 1835 as part of the 4th Judicial Circuit of Michigan comprising the counties of Oakland, Lapeer, Shiawassee, Genesee, Saginaw, Ionia and Kent. The first sessions of the Circuit Court were held on October 24, 1837.

Presently in Michigan, there are 3 types of courts related to County Government. All judges are elected to a 6-year term. Circuit Court is the highest trial court in the State and Saginaw County's 10th Circuit Court has 5 judges. This court hears civil cases involving more than \$25,000 and all felony criminal cases. It also hears appeals from District Court. Saginaw County has 6 District judges covering 2 divisions within the County's 70th District Court. These courts are the first level to hear criminal cases and give decisions on misdemeanor charges. They handle the small claims division and landlord tenant cases. The Probate Court has 2 judges and 2 divisions: Juvenile and Family Courts, which also handles Personal Protection Orders.

There is a court administrator who is responsible for supervising the day-to-day operations of both the District and Circuit/Probate Courts.

## **County Records**

Early minutes of Saginaw County Board of Supervisors and Commissioners are kept by the County Clerk or in the County Board Office. The first record of a marriage in Saginaw County is dated June 13, 1835. The first record of births and deaths is in 1864 as compiled from records in the Office of the County Clerk.

**Michigan - District 4**

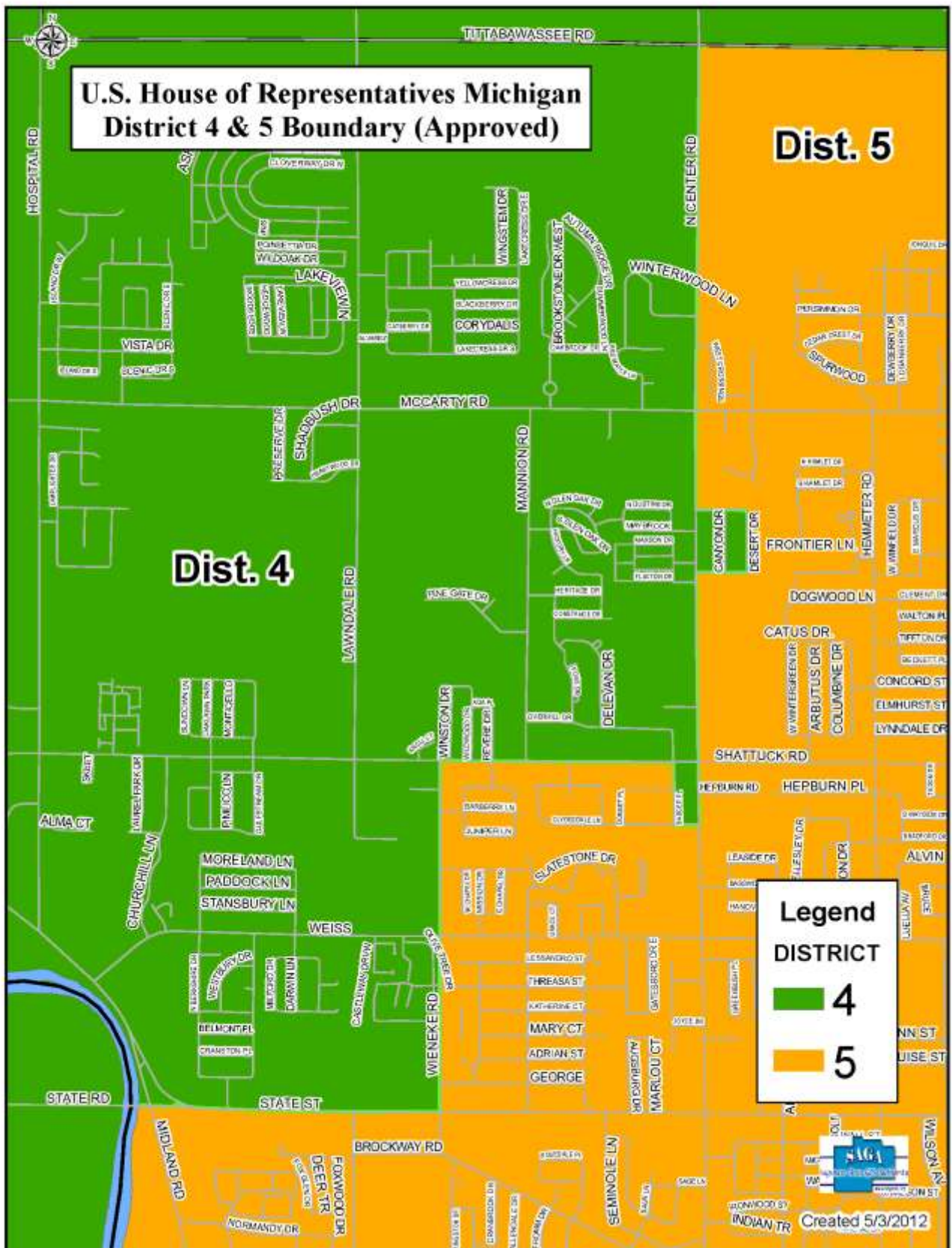


**Michigan - District 5**

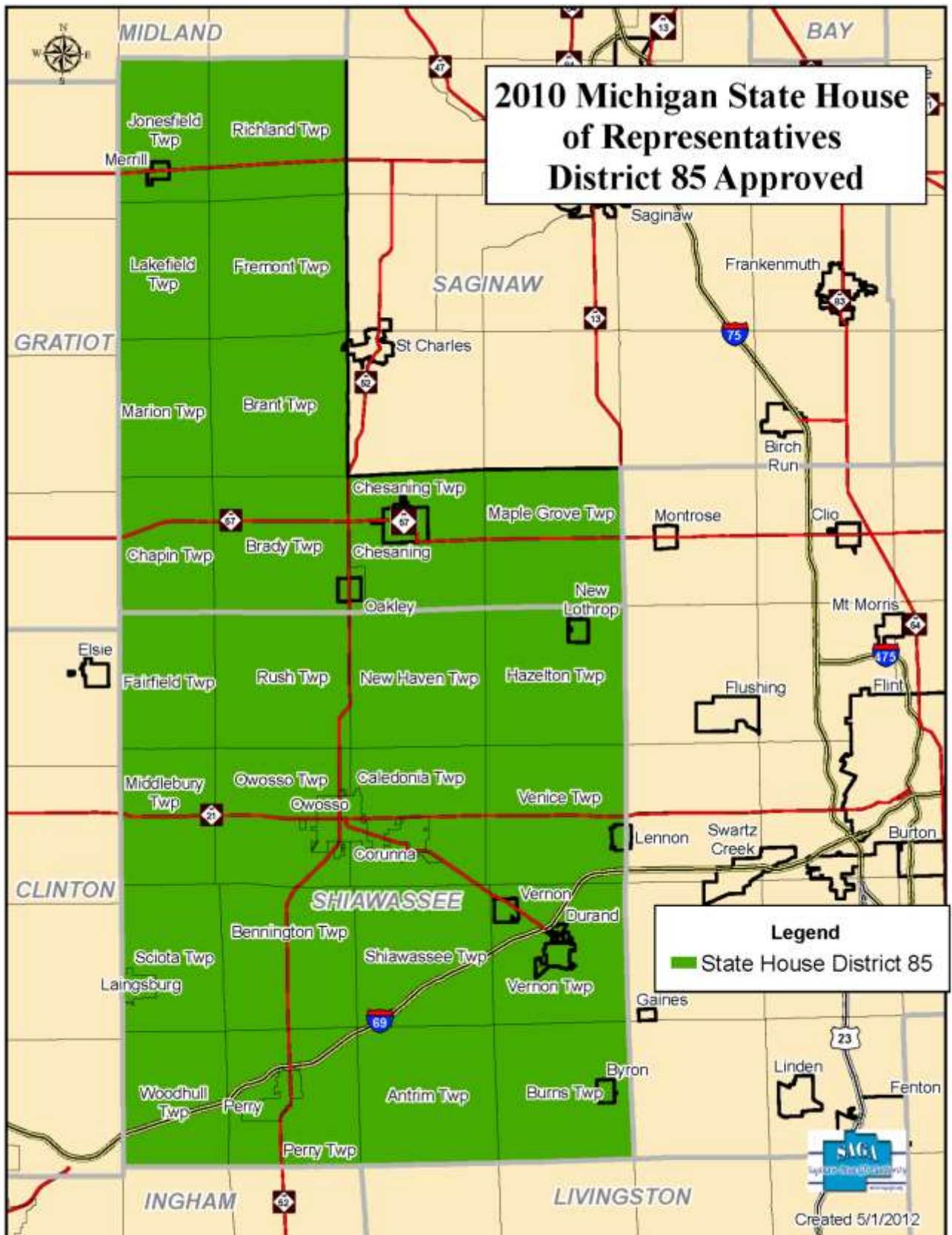




**Michigan - District 4 & 5 Boundary**

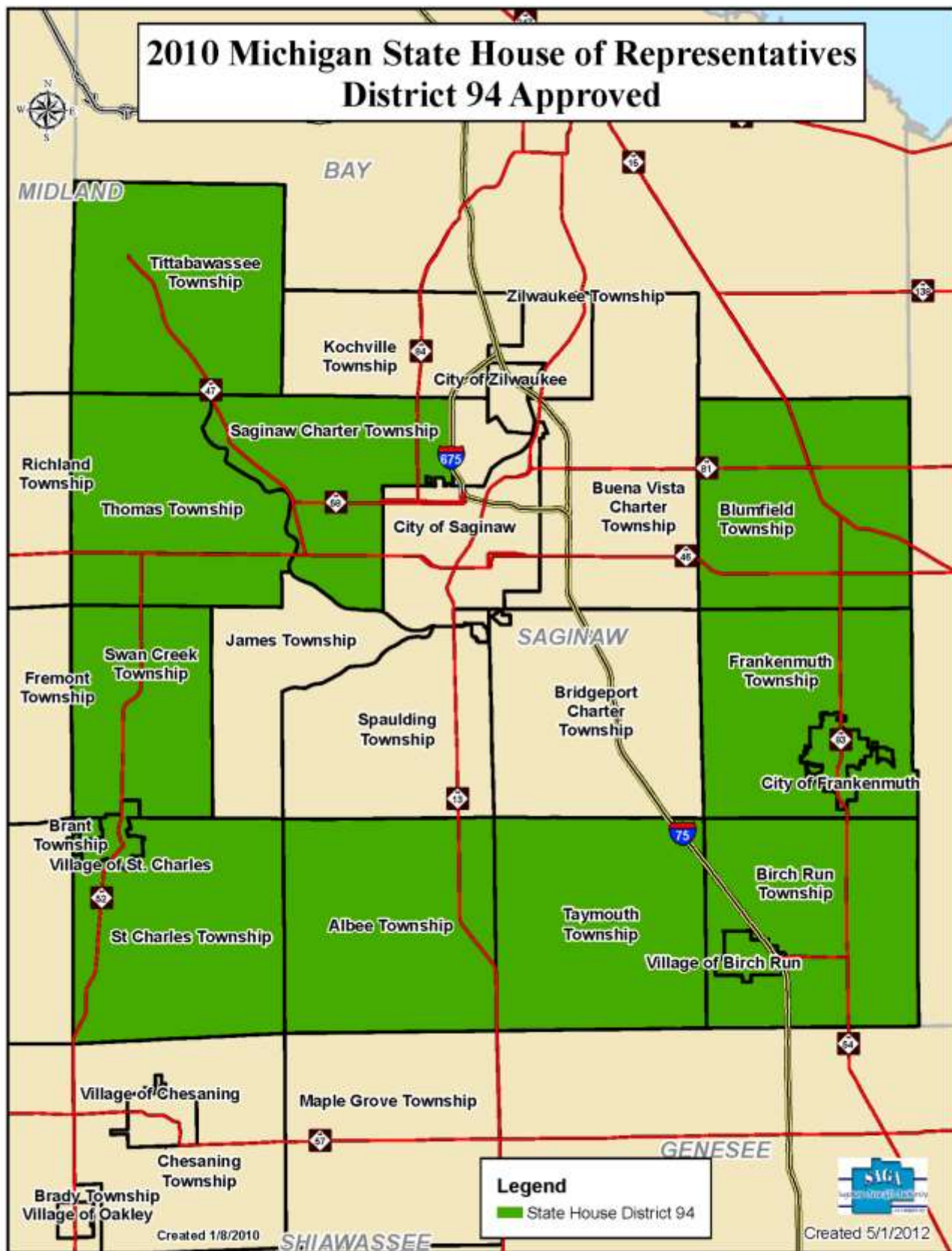


**Michigan State House of Representatives District 85**

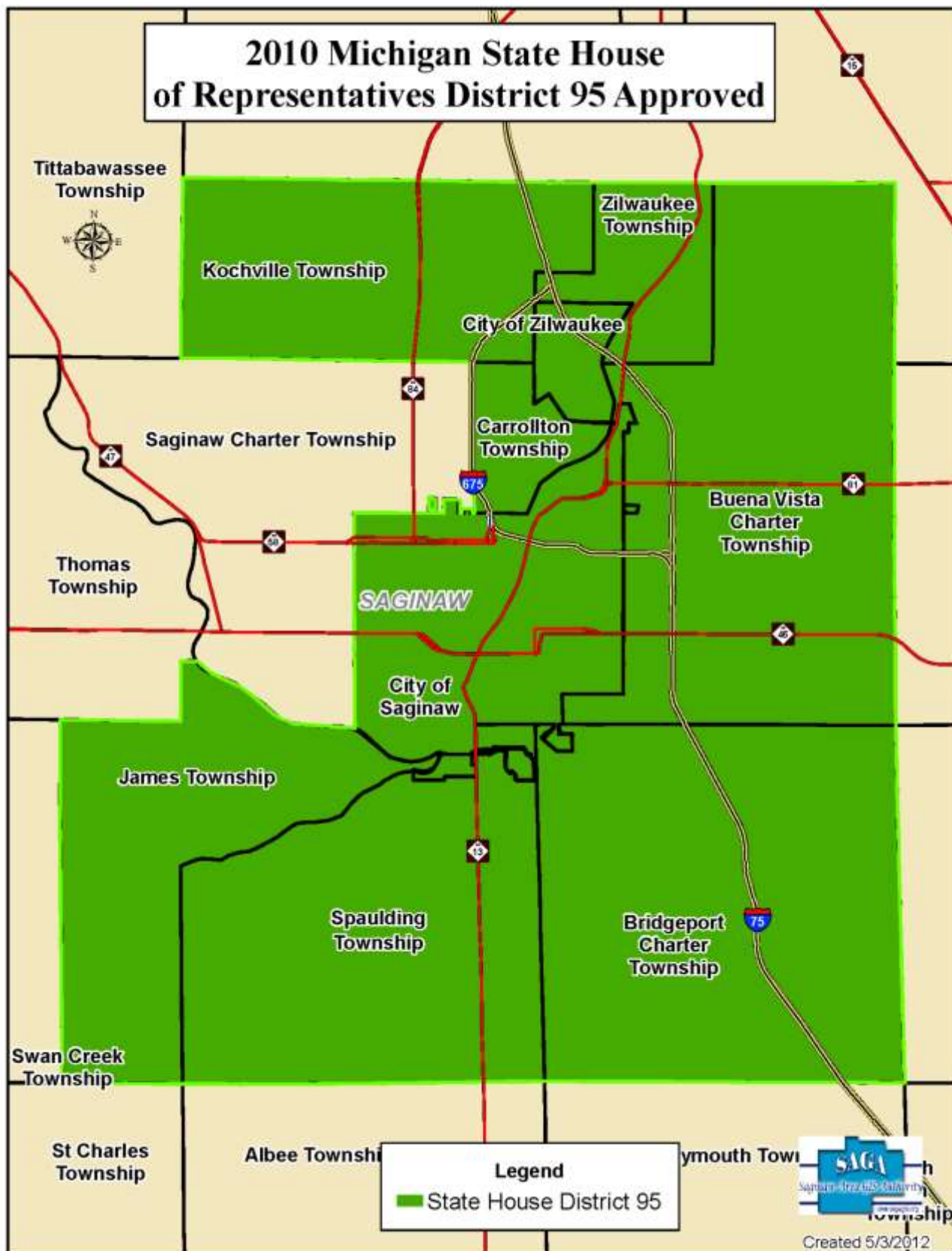




**Michigan State House of Representatives District 94**
