### 6. Public Comment:

Brush that was cut down two years ago on Hieber road from the Washtenaw county road commission still has not been picked up. The road is washed out in front of a residents home on Hieber road. CROW ask to put their yard sale sign out a week ahead of time in front of the Township hall. There will be an update on cemetery signs for the township cemetery's in July. Maintenance for the Fletcher cemetery the board is looking into who will take care of that cemetery.

### 7. Reports:

Planning Commission report: Finalized Waterlands permit. Review of boundary adjustment for ITC and a resident on Bethel Church road. Completed section 4 review on the zoning ordinance, the planner is drafting the revisions for section 1-4.

Clerks report: Meet with the auditor to review the draft of the audit, the board reviewed the draft and gave its ok on the audit.

Police Services – the board looked at information from the SWWCOG meeting and is waiting on information from the Washtenaw county sheriff's office to make a decision of what direction the Township should go with police services; topic was tabled until next month.

Fire chief Scully attended the meeting to discuss with the board, how to handle residents that are not eligible for a burn permit. Chief Scully will send a letter to the Township that the resident's privileges have been revoked for a year and a copy of the letter will be forwarded to the resident.
