## 2. <u>APPROVAL OF THE MINUTES FROM THE JUNE 15, 2011 MEETING</u>

## 3. JULY $4^{\text{TH}}$ EVENTS

#### 4. <u>VILLAGE VEHICLE STICKER CONTEST</u>

The Glencoe Park District is celebrating it's Centennial in 2012. Park District Executive Director Don Van Arsdale contacted the HRF and asked if the Village would consider putting a Park District theme on the annual Village vehicle sticker to commemorate their 100 year anniversary. Ironically, the Glencoe Girl Scouts are celebrating their Centennial next year and also asked if they could be on the vehicle sticker. A discussion was held on which organization might appear on the sticker as well as the possibility of putting them both on the sticker. It was noted that the Park District is a public entity and made their request before the Girl Scouts did. The Girl Scouts are technically a private entity so the decision was made to put the Park District on the 2012 Village Vehicle Sticker. Glencoe School Children will again be asked to design the vehicle sticker with the Park District as the theme. The schools will be contacted and a date will be set for next year's submissions. The winning design will again be chosen by the HRF.

## 5. <u>TASTE OF GLENCOE</u>

Discussion was held on the "Taste of Glencoe" to be held the day after Thanksgiving. It was suggested the name be changed to "Light the Night" as it will coincide with the Village tree lighting ceremony. It was suggested we contact St. Paul AME Church to see if their choir would perform at the ceremony. Additional discussion will be held at the next HRF meeting.
