GLENCOE HISTORIC PRESERVATION COMMISSION
TUESDAY, JUNE 7, 2011 MEETING MINUTES

1. CALL TO ORDER AND ROLL CALL

The June 7, 2011 meeting of the Glencoe Historic Preservation Commission was called to order at 7:34 p.m. in the Conference Room.

2. CONSIDER THE APRIL 5, 2011 MEETING MINUTES

The minutes of the April 5, 2011 Historic Preservation Commission meeting were approved.

3. NON-AGENDA ITEMS AND VISITORS

Resident Bob Sideman, newly elected to the Glencoe Historical Society, was present to discuss a possible initiative to increase the number of National Register properties in the Village. Mr. Sideman explained only three homes are currently listed on the National Register. Commissioner members were receptive to the idea and agreed to discuss the matter further with members of the Historical Society.

4. DISCUSS ANNUAL PRESERVATION AWARDS PROGRAM

Following the April 5, 2011 Historic Preservation Commission meeting, a letter was mailed to architects soliciting nominations for projects due by May 13th. An article also appeared in the May/June issue of the Glencoe Memo. Six nominations were received. Members of the Commission reviewed the nominations and were in agreement that two were eligible for participation in the 2011 awards program. One of the two was a duplication of a project reviewed at the April meeting. In total, 13 projects will be part of the 2011 awards program.

Commissioners discussed recognizing the Chicago Botanic Garden for several recent projects. Nathan Parch agreed to investigate further.

Two possible dates for judging were identified - Saturday, July 9th or Saturday, July 16th. Commissioners Eifler, Van Vechten, and Winn volunteered to find judges. It was agreed that the awards program would take place during the month of September.

5. **"INQUIRIES" AND DEMOLITION APPLICATIONS**

Commissioners reviewed demolition applications for 555 Sheridan Road, 159 Montgomery Street, and 618 Vernon Avenue and decided to take no further action.
