Village Planner Lee Brown explained the revisions that he incorporated based on comments, suggestions, and additions received from Plan Commission members following the February 24<sup>th</sup> Plan Commission meeting, at which time the *1<sup>st</sup> Discussion Draft* was reviewed.

Chairman Thomas emphasized that the document is a discussion draft and is not set in stone; it is intended to stimulate discussion in the community.

Members also discussed schedule for two community Open Houses. It was agreed that Mr. Parch would poll members for additional availability during the month of May.

Mr. Brown explained that the Open Houses would be interactive sessions intended for Plan Commission members and staff to share their findings from the Downtown TuneUp planning process with the community. The feedback received from participants at the Open Houses will help shape the conclusions and recommendations included in the Downtown Plan that will be forwarded to the Village Board for final consideration.
