1. CALL TO ORDER AND ROLL CALL

2. APPROVAL OF REGULAR MEETING & EXECUTIVE SESSION MINUTES - JANUARY 14, 2014

5. CONSIDER APPOINTMENT OF PUBLIC SAFETY OFFICERS

Upon a motion made by Chairperson St. Eve and seconded by Commissioner Rubenstein, the Public Safety Commission approved a recommendation not to extend offers of employment to Public Safety Officer candidates William Hall and Nicholas Tripoli. In addition, the following candidates were disqualified: Matthew Skalski, Michael Kakovan, Michael Kleinick, Ryan Evans, Ryan Robinson, Wilfredo Cadiz, and Michael Solski. With the conclusion of final interviews, declinations, and disqualifications, the posted Final Register of Eligibles (established February 22, 2013) has been exhausted. In anticipation of this possibility, staff conducted an entry-level written examination on May 28, 2014. Accordingly, members of the Public Safety Commission were made aware of the results of the written examination. The Commission discussed possible dates to conduct oral interviews, and tentatively agreed to schedule two days - July 18 & July 23, 2014 - from 8:00 a.m. until 6:00 p.m. in an effort to complete the process in a timely fashion. The next scheduled meeting of the Commission will be finalized once Commissioners confirm their availability.
