August 1, 2014 will be incorporated into the new final register of eligibles. Each candidate will be incorporated into the new final register of eligibles using his or her score listed on the August 1, 2014, Final Register of Eligibles. Those candidates will remain on the new final register of eligibles until July 31, 2016 (the date on which the August 1, 2014, Final Register of Eligibles would have expired).
