## 6. DISCUSSION REGARDING PUBLIC SAFETY OFFICER ENTRY-LEVEL TESTING

Assistant Village Manager Tanner summarized that the proposed entry-level Public Safety Officer testing process is similar to the most recent process. She summarized staff's recommendations to use Stanard & Associates to administer the application management process, administer the written exam and charge a \$45 application fee; create a first band of 30 applicants; add a pre-employment assessment center as examination element 1.5; modify element 3 to a preliminary character/background examination and add a final character/background examination; as well as the notice of examination, application questions and examination process. Commissioner Berlin made an omnibus motion to adopt staff's recommendations, and the motion was seconded by Chair St. Eve. Said motion was adopted by the following vote:
