


# Glencoe Public Safety Commission

## Public Safety Officer Final Register of Eligibles

Posted: May 18, 2016

Pursuant to the Glencoe Public Safety Commission Rules and Regulations, the following persons are hereby ranked in order of their relative excellence after successfully completing the written examination, pre-employment assessment center, preliminary character and background check and initial oral interview in the examination process for the entry-level position of Public Safety Officer, in addition to preference points. Candidates are ranked according to their final total points, including preference points. This final list shall remain effective for a period of two years from the date of final posting, or until such time as the list is exhausted of acceptable candidates, whichever comes first.
