- AGGRESSIVE AND ACHIEVABLE CAPITAL PLAN

- 10-YR CAPITAL PLAN
- ANNUAL BUDGET PROCESS- FUNDING AND PRIORITIZE PROJECTS

## Capital Improvement Plan

### **IMPLEMENTATION- CONSTRUCTION**

- DESIGN/BID TO START OF CONSTRUCTION 60 TO 90 DAYS PROCESS
- ALL CONTRACTS INCLUDE CONTINGENCY DAYS
  - Weather Delays
  - Holidays
  - Field Changes
- CONSTRUCTION TIMELINE DURATION- MAY THRU NOVEMBER
- ASPHALT PLANTS OPEN MID-APRIL TO END OF NOVEMBER
- CONSTRUCTION SEQUENCING
  - Underground Work –First
  - Curbs and Driveways- Second
  - Paving-Last
  - Delay of a Task Shortens Contingency Days



# **BIDDING PHASE**

- POST PLANS TO ONLINE BIDDING PORTAL (QUEST-CDN)
- ANSWER QUESTIONS RECEIVED FROM POTENTIAL BIDDERS
  - If necessary, issue an addendum to address questions
- OPEN BIDS
  - Online via internet
  - Bid results instant
- REVIEW BID DOCUMENTS SUBMITTED BY BIDDERS
  - Bid bond
  - Prequalification's (typically IDOT prequalified for proposed work)
  - Finalize Bid Tab to show summary of bid results
- CITY COUNCIL APPROVAL
  - Bid documents, bid results and staff recommendation to City Council

#### RE: START OF CONSTRUCTION NOTICE

2018 MFT Asphalt Street Repair Program Streets with new Concrete Curb and Gutter (Cedar Av, Kimball Rd)

#### Start of Construction

Mobilization and construction are expected to begin the week of August 13, 2018, weather permitting.

#### Project Scope and Award

The City of Highland Park awarded the 2018 MFT Asphalt Street Repair Program to Peter Baker & Son Company. Proposed improvements include:

- · Milling off a layer of existing asphalt from the pavement
- · Installation of a new layer of asphalt
- Installation of new drainage structures
- \*Construction of New Concrete Curb and Gutter along the outer edge of the pavement
- · Minor Landscape Restoration with seed or sod
  - \*The new curb and gutter will convey storm water runoff into existing storm sewers, improving drainage and extending the pavement life.

#### Limited Access/Parking

During construction, access will be allowed to the properties in the work area, however, traffic may be directed one-way at a time with flaggers as needed. When the new concrete curb is constructed access to your driveway will be temporarily restricted for approximately one week. This is necessary to allow the new concrete curb to cure so the concrete reaches sufficient strength to allow cars to drive over it. The City will provide notice in advice of the concrete curb work so that you may remove your car from your driveway. On some occasions this notice may occur the day before your access will be limited. The delivery of the notice is dependent on the work that will take place and how weather affects the schedule.

#### Proposed Work

The City's contractor will form and install your concrete driveway apron along North Avenue.

#### Locations Affected by Work

#### Impact to Driveway Access

Weather permitting, the removal of the apron will start on Friday, 11/30. Access to your driveway will be restricted from 11/30 – 12/06. Please have your vehicle removed from your driveway by 7am on Friday, 11/30. You will not have access to your driveway while the concrete cures. You will be permitted to park on Idle Wood Ln. while you do not have access to your driveway. We expect you to regain access to your driveway on Thursday 12/06 once all barncades have been removed. Please keep in mind that inclement weather (rain/snow) can affect the completion date for this work.

We understand this is a short notice, but with the impending weather the contractor has requested to install the aprons on 11/30. The City of Highland Park along with the Contractor appreciates your patience and understanding.





The project includes the re-grading of roadside swales and installation of new pipe culverts under driveways along Grove Avenue. The proposed improvements and will address standing/pooling water in the parkway and enhance conveyance of storm water runoff which improves drainage. Other improvements include reconstruction of the existing pavement with a full depth asphalt pavement and new flat concrete curbs at the edge of the new pavement. The flat concrete curb will help hold the asphalt edge in place which extends the pavement life.

Construction is complete.







BASE BID - NORTH AVENUE WATER MAIN & SUMMIT AVENUE ROADWAY IMPROVEMENTS





- Sandy, Wet Soil Conditions
- Develop an alternate plan for construction
  - Open Cut to Directional Boring
  - Minimal Impact to Residents
  - Critical Path Delayed



- SUBSTANTIAL COMPLETION DATE DECEMBER 11, 2018
- SPRING 2019 FOLLOW UP
  - NO IMPACT TO TRAFFIC
  - PARKWAY RESTORATION
  - MINOR PUNCH-LIST CORRECTIONS
  - MISC. REPAIRS

# 2019 AND BEYOND CONTRACT COMMUNICATION ENHANCEMENTS

  - LIMIT NUMBER OF DAYS FOR DRIVEWAY INACCESSIBILITY
