VEHICLE STICKER MUST BE AFFIXED TO THE LOWER DRIVER'S SIDE OF THE FRONT WINDSHIELD BY OCTOBER 1

DO NOT TEAR APART. Return entire application and a check in the envelope provided. DO NOT SEND CASH. Allow 10 days for mail delivery.

Please be advised that vehicle stickers expire September 30. Violators will be assessed a \$10.00 late fee and may be subject to a \$50.00 fine if new stickers are not displayed by October 1st. *Affix sticker immediately upon receipt.

Highland Park vehicle stickers must be affixed to the lower driver's side of the front windshield. Water is not necessary, and tape must not be used to attach the sticker to the windshield.

Proof of purchase is required by the City of Highland Park to receive a transfer or replacement sticker. The above fees are reduced 50 percent after March 31 for new residents or newly purchased vehicles.

* Note: A vehicle owner who has properly purchased and obtained a vehicle sticker prior to October 1 of a sticker year but subsequently receives a citation for failing to properly display the sticker on the vehicle in violation of Section 74.020(A) of this chapter may seek to nullify that citation by filing a Request to nullify with the Chief of Police, or his designee, pursuant to this Section 74.020(B). **(Ord. 34-11, J.37, P. 142-144, passed 4/11/11)**
