

PATROL

The patrol bureau strives to provide the highest level of professional police services to all people within the Village of Huntley. The patrol function is considered to be the primary law enforcement function and embraces much more than the act of patrolling. Patrol officer duties include:

- Preventative patrol on foot, bicycle or squad car
- Respond to emergency and nonemergency calls for service
- * Enforce local and state laws
- * Maintain public order
- * Suppress and prevent crime

- * Conduct preliminary investigations
- * Enforce traffic laws
- * Provide traffic direction and control
- * Investigate traffic crashes
- Develop and foster positive relationships between citizens and the agency

The **Community Response Team (CRT)** focuses on quality of life concerns, crime prevention and outreach projects. It is focused on building stronger connections with the community and rapidly addressing their concerns.

CRT duties include coordination of community events, Coffee with a Cop, home security surveys, educational events and presentations, and special traffic or nuisance complaints.





A **drone program** was fully implemented this year, with a drone purchase and continued training of officers as drone pilots. The drone can be used in situations such as missing person cases, crash or crime scene photography, and survey storm or other natural disaster damage.





Officer Keppler was sworn in and joined the Patrol Services Bureau.

Foot Patrol is an important part of every officer's shift. This practice allows the officers to get out of the squad car and interact with our community members. When you see officers walking through a neighborhood, park or local business please feel free to stop and discuss any concerns with them.





The **Bike Patrol** program continues to be a popular and important part of our community-based policing program. Currently, there are 13 officers assigned as Bike Patrol Officers. Bike Patrol allows better community interaction and enforcement, especially in residential neighborhoods and parks.

AREA SERGEANTS

The Huntley Police Department is structured to deliver police services through the practice of geographic policing. The Village has been divided into four Areas, and the assigned Area Sergeant is responsible for the community needs in that specific Area, including:







Crime 8 Year Trend







Calls for Service 8 Year Trend







Patrol participated in several **special traffic enforcement events** which include public safety educational campaigns and increased enforcement efforts:

- DUI enforcement details were conducted on St. Patrick's Day, the day before Thanksgiving, and New Years Eve
- · Distracted Driving Awareness Week in April

- Illinois Rail Safety Week in September

The **Child Safety Seat** program consists of an officer certified through Safe Kids Worldwide, using the NHTSA curriculum. We conducted 12 car seat installations and inspections for residents and offer educational materials online.



INVESTIGATIONS


The investigations section handles cases that require a more thorough inquiry or go beyond the scope of the patrol officer. This often includes locating witnesses, scheduling interviews, conducting searches, processing evidence and coordinating with the appropriate county prosecutor.

Throughout this process, detectives also maintain an open line of communication with victims to ensure they are informed of the investigation and make referrals and resources available as needed. Detectives generally work during weekday hours but are available 24/7 should they be needed at a crime scene or for an investigation.

Sergeant Hooten worked with the **Sexual Assault Response Team** on to implement updates to county-wide policies and protocols for new state laws that took effect January 1, 2018. All Huntley Police Detectives received training in response to sexual assaults.

A **K-9 search at Huntley High School** was conducted, resulting in the collection of multiple illegal items.

No residential burglaries were reported in Del Webb in 2018. We will continue aggressive patrol, investigation, and prosecution of the burglars.

Alcohol compliance checks were completed on 21 establishments that sell liquor in the Village. Three businesses were found in violation of Village ordinance as a result of this check.

Tobacco compliance checks were completed on 12 establishments that sell tobacco products in the Village. All the businesses were found in compliance with the Village ordinance as a result of this check.

SUPPORT SERVICES

The **Records Division** is staffed by 2 clerks Monday through Friday, 8 am to 5 pm. Stats for 2018 include:

- * 3,660 lobby visitors assisted
- 6,727 telephone inquiries handled
- 26 subpoenas processed
- * 610 requests for records processed
- 204 Freedom of Information Act (FOIA) requests processed

The **Community Service Officer** provides support services that do not require physical arrest or relate to a crime in progress. Duties include:

- Vehicle lock-outs
- Ordinance violations
- School crossing/traffic control
- * Fingerprinting

- * Animal complaints
- Citizen/motorist assists
- * Accident reports
- Assist fire/ambulance/other agency

The **medication disposal program** allows citizens a safe and convenient option to remove unused medication from the home. We disposed of over 428 pounds of medication through the lobby Medication Disposal Box. Additionally, two National Take Back Events with the DEA collected another 120 lbs of medication.

Our **Recruitment Team** focused efforts on finding the best candidates for the 2018 exam to create a new officer eligibility list. Members attended recruiting events at the University of Wisconsin - Platteville and Western Illinois University.

In response to the opioid abuse epidemic in our country, we became a partner in the McHenry County **A Way Out** program. This program allows individuals fighting addiction to come to a participating police department and request help. Staff provides transportation to a facility for substance abuse assessment and assistance with placement in the determined level of care.



As a part of the new standards process for the Commission on Accreditation of Law Enforcement Agencies (CALEA), HPD successfully completed its second annual file review. Since initially earning accreditation in 2010, HPD had previously gone through reaccreditation processes every three years to maintain our status. After our most recent award in 2016, we moved into the new CALEA program which requires annual reviews in addition to the extensive final assessment at the completion of the

new four year cycle. The annual assessment yielded very positive feedback from CALEA staff on the policies, operations, and practices of the department.

HPD is also an active member of the **Illinois Police Accreditation Coalition (IPAC)**, which serves as a professional resource for agencies striving towards and maintaining the rigorous accreditation standards. Staff attended 6 meetings and assisted in 4 mock assessments in 2018.

TRAINING

Training is imperative to the safe, effective performance of our duties and has often been cited as one of the most important responsibilities in any law enforcement agency. Training serves three broad purposes. First, well-trained officers are generally better prepared to act decisively and correctly in a broad spectrum of situations. Second, training results in greater productivity and effectiveness. Third, training fosters cooperation and unity of purpose.

Our goal is to create a training environment that inspires enthusiasm, devotion to duty, initiative, determination, integrity, camaraderie and the willingness to train with others and for excellence in reaching all Department goals. Evaluation of the training program is ongoing to ensure that we are meeting the needs of officers as the expectations of law enforcement evolve and legislative requirements for officers change.



In 2018, Members of the Huntley Police Department, including sworn officers and civilian staff, had a combined **total of 3,776 hours of training**. Each sworn officer received at least 40 hours of training and support staff received an average of 18 hours. The training varies not only in topic but also delivery method, including outside providers, online programs, and in-house presentations and classes.

Four 8-hour **in-service training** days was held on legal updates, defensive tactics, firearms qualifications, deescalation tactics and policy review.

A joint **active threat tabletop exercise** was held with Centegra Hospital security staff and the Huntley Fire Protection District.

A **Code Red Drill** was conducted at Huntley High School and Leggee Elementary with theHuntley Fire Protection District and the Southeast Emergency Communication Center (SEECOM).

Staff attended various **specialized trainings** such as lead homicide investigator, traffic crash investigation, instructor development, school safety, crime analysis, and problem-oriented policing.

To ensure we continue to offer the best training program possible, the **career path training modules** were revised. Modules were updated or created for all positions, including specialty positions, for both sworn and civilian staff.



TASK FORCES



Participation in task forces is important in many ways. First, it helps other agencies who request the help of the task force, thereby advancing our collective mission of law enforcement. Additionally, it provides staff diverse opportunities they may not have within the Village of Huntley. The task forces provide training and advancement opportunities that enhance the careers of our officers, allowing them to bring the acquired knowledge and skills back to the HPD. Finally, these groups are a great resource that HPD can call on when we have an extraordinary situation.



The McHenry County Major Investigation Assistance Team (MIAT) provides support to agencies in need of assistance with major investigations. Deputy Chief Fulton serves as MIAT Deputy Commander and another HDP detective is assigned to the team. In 2018, they participated in 4 meetings, 1 training session and 1 investigation call out. Additionally, MIAT was called in to assist HPD with one investigation.

The **Kane County Major Crimes Task Force** provides support to agencies in Kane County in need of assistance with major investigations. We attended 1 training and responded to 2 investigation call outs this year.







The Kane County Accident Reconstruction Team (K-CART) provides high-tech, specialized teams to investigate crashes in municipalities without such capabilities. Two HPD officers are assigned to this team, including Sergeant Keane who is an Illinois State Certified Crash Reconstructionist. HPD staff responded to 2 investigation call outs and attended 1 training session.

The **Illinois Law Enforcement Alarm System (ILEAS)** is a statewide police mutual aid system. Deputy Chief Mike Klunk serves as a Team Leader and 2 other officers are assigned to the team. Assigned staff attended 8 Mobile Field Force training sessions. Additionally, they attended the annual conference and 6 Team Commander meetings.



PROFESSIONAL STANDARDS

The Office of Professional Standards (OPS) is an organizational component of the police department established to investigate all Administrative Inquiries and Performance Complaints against police employees related to internal discipline, violations of Statutes, Village Ordinances and General Orders. OPS investigations serve to not only to hold employees accountable for misconduct, but also to exonerate employees from false accusations. Having a robust professional standards process is vital for employee accountability and public trust.

YOUTH PROGRAMS

The **School Resource Officer (SRO)** is on campus during school hours to provide positive assistance when students need individual intervention or support. The SRO is also a classroom resource for instruction on laws, safety and alcohol & drug prevention, as well as being instantly available to help the school deal with any safety or law-related issues.

LEAD the Way (Learning Effective and Assertive Decision-making) is a program developed by the Huntley Police Department to educate Leggee Elementary 5th graders on drug awareness and life skills as they approach middle school. The program engages students with discussion,

individual reflection and participation in group activities and games and provides tools and information to prepare students for the pressures and issues pre-teens Topics include tobacco, face today. alcohol, marijuana, prescription medications, bullying, peer pressure and internet safety. There were 185 graduates of the program in 2018. Police Departments in Glenview and Lake in the Hills have also adopted our LEAD the Way program and have begun teaching this to 5th grade students in their jurisdiction.





Summer Teen Forum is the annual 3program for HHS incomina freshmen. Sponsored by HPD with the support of Lake in the Hills PD and the McHenry County Sheriff's Office, the forum is designed to establish positive law enforcement relationships with area youth and provide important information for students entering high school. Topics include bullying, dating violence, drug & alcohol awareness and risks online and in social networking. forum had 27 attendees this year, the maximum capacity.



HPD provides **station tours** for groups such as Boy and Girl Scouts of America, preschools and daycares. In addition to seeing the police facilities and fleet, the tours often include a discussion on the role of law enforcement officers and age-appropriate safety tips. We conducted 7 tours in 2018.

Peer Jury, or the Tri-Area Court for Teens, is a diversion program for first time juvenile offenders. Participants must be referred to the program by the arresting juvenile officer and meet other eligibility requirements. This program allows offenders to accept responsibility for their actions and receive a penalty without having a conviction on their record. A group of volunteer teens act as jurors and decide a penalty for the offender (i.e. community service, apology letters, restitution). HPD referred 11 teens in 2018.

To help promote bike safety, 1 **bike rodeo** was held this year. These events allow children of all ages to have their bikes registered and inspected while their riding skills are tested. Officers and volunteers also discuss safe riding procedures, traffic laws and the importance of proper protective gear.

Organized by the Huntley High School Service in Action class, we participated in a friendly volleyball game at Cosman Center, called **Badges vs Backpacks**. It was a fun day that continued our positive relationship with youth in our community.

In 2018 we expanded our popular Coffee with a Cop program to include a **Juice with a Cop** event. Officers came to the Discovery Zone in Deicke Park and invited the community to join us for juice and coffee. It was a wonderful opportunity to interact with the youth in our community and their caretakers.





COMMUNITY PROGRAMS

The Citizen Police Academy (CPA) provides a working knowledge of the Huntley Police Department to interested citizens. In 10 weekly, interactive classes participants learn more about law enforcement and the efforts of our department. This popular program had 25 graduates for 2018. Graduates of the CPA are eligible to join the Citizen Police Academy Alumni Association (CPAAA) which meets regularly to learn about community safety issues and provides volunteer support to the Police Department.





Community Emergency Response Team (CERT) provides critical support to first responders in emergency or disaster events. More commonly, this team is used for safety related non-emergency tasks, such as traffic control and support at special events. Membership requires training in disaster preparedness, first aid, search and rescue, fire suppression and organization.

The **Police Explorers Program** is designed to give insight into law enforcement careers for young men and women aged 14 to 20, through hands-on activities. Meetings are held every other Thursday in the Village Board Room. For more information, contact Officer Heagney at theagney@huntley.il.us or 847-515-5402.





Neighborhood Watch is a crime prevention through community partnership program to enable officers and community members to work together to reduce crime. Watch groups provide an extra set of eyes and ears in the neighborhoods. Meetings are regularly attended by officers that are assigned to patrol that neighborhood. If you are interested in starting a Neighborhood Watch group, please contact your Area Sergeant (see page 9).

Coffee with a Cop is a national initiative supported by the United States Department of Justice, Office of Community Oriented Policing. These are informal gatherings of officers and citizens to discuss community issues, build relationships and drink coffee. There were 4 events held at local restaurants and neighborhood locations in 2018.

Speaker's Bureau is available on request for an officer to speak to groups. Topics include scams and fraud, pedestrian safety, and home/business security. Topics can be tailored to your group's interests and needs.





The annual **Bike Huntley** event was a huge success. This community wide bike ride is presented by the Police Department in conjunction with the Village of Huntley and the Huntley Park District. Approximately 100 citizens came together to enjoy a fun ride and party in the square.

National Night Out (NNO) is an annual event held on the first Tuesday of August in communities across the nation. NNO is designed to heighten crime prevention and drug awareness, as well as strengthen neighborhood spirit and foster community partnerships. This year's events began with HPD winning the annual softball game vs Huntley Fire. An open house was held at the Police Station featuring tours, games, a dunk tank (valiantly manned by Sergeant Sullivan), a bike rodeo and equipment display with the Huntley Fire Protection District. 2018 ACCOMPLISHMENTS

- Five officers were certified as Crisis Intervention Officers
- All sworn employees and the CSO were trained in de-escalation techniques
- A program, staffing, and responsibilities review was completed and recommendations were made for 2019 implementation
- A specialty position rotation schedule was established to facilitate staff development
- A multi-agency training exercise was completed at Northwestern Medicine Huntley Hospital that included police, Huntley Fire Protection District and hospital security staff
- A Sergeants promotional process was held and a new list established
- A new in-car camera system was purchased and installed in all squad cars
- A Social Services Coordinator was engaged to assist in handling difficult mental health situations, domestic violence cases and miscellaneous sensitive matters
- A full review of the Police Commission Rules and Regulations document was conducted in coordination with the Human Resources Manager, with several amendments approved by the Village Board
- An annual file review was completed by CALEA, with the department found to be in compliance
- A multi-agency school safety committee was established to address local issues and national school threats
- All officers were trained in emergency tactical first aid, including the distribution of tourniquets for field operations
- All sworn staff was trained in mental illness awareness for law enforcement
- Two officers successfully completed the SWAT Certification course and serve as members of the Kane County SWAT Team
- The Administration team held quarterly division-specific staff meetings
- The Police Department partnered with the Huntley Fire Protection District and School District 158 to improve radio communication issues at Huntley High School
- The Drone Program policy was developed and four officers were trained as drone pilots
- The Police Department increased the number of volunteers and the number of events with which the volunteers assisted

- Increase staff development opportunities to include additional leadership based training
- Increase number of bike patrols from previous year
- Develop comprehensive plan for Village-wide, full scale emergency exercise in 2020
- Oversee the modifications to the Emergency Operations Center
