PATROL

Huntley Police Department 2017 Annual Report

The patrol bureau strives to provide the highest level of professional police services to all people within the Village of Huntley. The patrol function is considered to be the primary law enforcement function and embraces much more than the act of patrolling. Patrol officer duties include:

- *Preventative patrol on foot, bicycle or squad car
- *Respond to emergency and nonemergency calls for service
- * Enforce local and state laws
- * Maintain public order
- * Suppress and prevent crime

- * Conduct preliminary investigations
- * Enforce traffic laws
- * Provide traffic direction and control
- * Investigate traffic crashes
- Develop and foster positive relationships between citizens and the agency

Through the efficient and effective use of personnel and supporting resources, the patrol bureau provides optimal service to the community 24 hours a day, 7 days a week within a geographic based policing concept.



The Community Response Team (CRT) focuses on quality of life concerns, crime prevention and outreach projects. It is focused on building stronger connections with the community and rapidly addressing their concerns.

CRT duties include coordination of community events, Coffee with a Cop, home security surveys, educational events and presentations, and special traffic or nuisance complaints. **Foot Patrol** is an important part of every officer's shift. This practice allows the officers to get out of the squad car and interact with our community members. When you see officers walking through a neighborhood, park or local business please feel free to stop and discuss any concerns with them.





The **Bike Patrol** program continues to be a popular and important part of our community-based policing program. Currently, there are 13 officers assigned as Bike Patrol Officers. Bike Patrol allows better community interaction and enforcement, especially in neighborhoods and parks.

A **drone program** was initiated in 2017. The drone purchase was authorized and several officers began training as drone pilots. Additional training on legal requirements and restrictions of law enforcement drone use will continue in 2018. The drone is anticipated to be used in situations such as missing person cases, crash or crime scene photography, and survey storm or other natural disaster damage.

Two **new patrol vehicles** were purchased and deployed this year.

One HPD officer serves on the **McHenry County Chiefs of Police Honor Guard**. This group is mobilized for special events in the county, such as Illinois Police Memorial ceremonies and law enforcement funerals.





AREA SERGEANTS

The Huntley Police Department is structured to deliver police services through the practice of geographic policing. The Village has been divided into four Areas, and the assigned Area Sergeant is responsible for the community needs in that specific Area, including:

- Working with neighborhood watch groups
- Serving as a conduit between the community and the police department





Part II Crimes consist all other crime reports, including traffic arrests.


Other Activities & Services reports include all other reports such as lock outs, accidents, well being checks, alarms, missing persons, assists to other agencies, etc.





As the above chart shows, crime in the Village of Huntley is low and has been on a downward trend over this decade. This is particularly notable given the growth the Village has seen in terms of population and business.

The total calls for service to the Huntley Police Department as well as the types of calls is consistent with our numbers from last year.





Command staff continually assesses these numbers to ensure that we are not only staffed accordingly, but that our resources are deployed to provide optimal service and safety to the Village of Huntley.


TRAFFIC ENFORCEMENT



The **Traffic Safety Committee** works to develop a comprehensive approach to traffic safety issues within the Village. The committee meets regularly to discuss ongoing traffic issues, possible solutions, and training opportunities for officers.

The Village of Huntley saw a slight **decrease in traffic accidents** in 2016 and 2017, reversing a three year trend of increasing accident reports.

Officers participated in 5 **special traffic enforcement details** in 2017:

- Illinois Distracted Driving Awareness Week (April 24-28, 2017)
- DUI No Refusal Independence Day (July 4, 2017)
- Illinois Speed Awareness Day (July 26, 2017)
- Illinois Rail Safety Week (September 24-30, 2017)
- DUI No Refusal Thanksgiving Eve (November 22, 2017)



These campaigns included additional patrols, enforcement activities, education, and social media coverage.

The **Child Safety Seat** program continued with officers certified through Safe Kids Worldwide, using the NHTSA curriculum. We conducted 39 car seat installations and inspections for residents this year. Additionally, Officer Heagney conducted 8 educational presentations as a part of the Centegra Hospital Huntley's childbirth education program, focusing on proper car seat selection, installation and use.

INVESTIGATIONS

The investigations section handles cases that require a more thorough inquiry or go beyond the scope of the patrol officer. This often includes locating witnesses, scheduling interviews, conducting searches, processing evidence and coordinating with the appropriate county prosecutor.

Throughout this process, detectives also maintain an open line of communication with victims to ensure they are informed of the investigation and make referrals and resources available as needed. Detectives generally work during weekday hours but are available 24/7 should they be needed at a crime scene or for an investigation.

Sergeant Hooten worked with the **Sexual Assault Response Team** on updates to county-wide policies and protocols in preparation for new state laws that take effect January 1, 2018.

A **K-9 search at Huntley High School** was conducted, resulting in the collection of multiple illegal items.

No residential burglaries were reported in Del Webb in 2017. We will continue aggressive patrol, investigation, and prosecution of the burglars.

Our **forensic interviewer** completed 11 forensic interviews for cases from Huntley and other jurisdictions. These are structured conversations with a child intended to elicit detailed information about possible events that the child may have experienced or witnessed.

Training was provided to **Huntley School District 158** administrators on handling student reports of sexual assault and abuse.

Alcohol compliance checks were completed on 22 establishments that sell liquor in the Village. All businesses passed the compliance check.

Tobacco compliance checks were completed on 11 establishments that sell tobacco products in the Village. Two businesses were found in violation of Village ordinance as a result of this check.

The **Records Division** is staffed by 2 clerks Monday through Friday, 8 am to 5 pm. Stats for 2017 include:

- 3,763 Lobby visitors assisted
- 7,468 Telephone inquiries handled

- 19 Subpoenas processed
- 512 Requests for records processed
- 192 Freedom of Information Act (FOIA) requests processed

The Community Service Officer provides support services that do not require physical arrest or relate to a crime in progress. Duties include:

- Vehicle lock-outs
- Ordinance violations
- School crossing/traffic control
- Fingerprinting

- Animal complaints
- Citizen/motorist assists
- * Accident reports
- Assist fire/ambulance/other agency

The medication disposal program allows citizens a safe and convenient option to remove unused medication from the home. We disposed of over 250 lbs of medication through the lobby Medication Disposal Box. Additionally, a National Take Back Event with the DEA collected another 14 lbs of medication.

HPD implemented the **NIXEL 360** notification system to send citizens emergency alerts and community updates via text message or email. The program is free to the public but they must enroll at www.nixle.com.



Due to legislatively mandated dispatch consolidation, the Lake in the Hills dispatch center closed in May. HPD successfully moved to SEECOM in Crystal Lake for dispatch services. This also included a switch to STARCOM radios.

In response to the opioid abuse epidemic in our country, we became a partner in the McHenry County A Way Out program. This program allows individuals fighting addiction to come to a



participating police department and request Staff provides transportation to a facility for substance abuse assessment and assistance with placement in the determined level of care.

SUPPORT SERVICES

As a part of the new standards process for the Commission on Accreditation of Law Enforcement Agencies (CALEA), HPD successfully completed its first annual file review. Since initially earning accreditation in 2010, HPD had previously gone through reaccreditation processes every three years to maintain our status. After our most recent award in 2016, we moved into the new CALEA program which requires annual reviews in addition to the extensive final assessment at the completion of the new four year cycle. The annual assessment yielded very positive feedback from CALEA staff on the policies, operations, and

practices of the department.

HPD is also an active member of the **Illinois Police Accreditation Coalition (IPAC)**, which serves as a professional resource for agencies striving towards and maintaining the rigorous accreditation standards. Staff attended 6 meetings and assisted in 4 mock assessments in 2017.

A new **Village of Huntley website** was launched, which included substantial updates the Police Department section.

We continued to enhance our **social media presence** in 2017. Follow us to keep up to date on public safety information, community events, traffic concerns, and what is new in our department.



Our Facebook page (@HuntleyPolice) published 205 posts and added 823 new followers in 2017.



The HPD Twitter account (@HuntleyPolice) published 127 tweets and added 179 new followers. We also added an SRO Twitter (@SROHuntley) in July, who published 16 tweets and gained 48 followers last year.



Additionally, we expanded our social media reach in December with an Instagram account (@HuntleyPolice) and posted 8 times and gained 193 followers.

Our **Recruitment Team** attended career fairs at University of Wisconsin Platteville and Huntley High School.

A **new officer eligibility** list was compiled. Candidates completed a written examination and oral interview that determined their ranking on the list. The eligibility list is good for two years or until it is exhausted.

A **Sergeants Promotional Process** was held to create a new list of candidates for promotion. Every three years, qualified officers may participate in the process which includes a written test and oral interview. Officers are ranked and that list is used in the event of an opening for a sergeant position in the department.



TRAINING

Training is imperative to the safe, effective performance of our duties and has often been cited as one of the most important responsibilities in any law enforcement agency. Training serves three broad purposes. First, well-trained officers are generally better prepared to act decisively and correctly in a broad spectrum of situations. Second, training results in greater productivity and effectiveness. Third, training fosters cooperation and unity of purpose.



TASK FORCES

Huntley Police Department 2017 Annual Report

Participation in task forces is important in many ways. First, it helps other agencies who request the help of the task force, thereby advancing our collective mission of law enforcement. Additionally, it provides staff diverse opportunities they may not have within the Village of Huntley. The task forces provide training and advancement opportunities that enhance the careers of our officers, allowing them to bring the acquired knowledge and skills back to the HPD. Finally, these groups are a great resource that HPD can call on when we have an extraordinary situation.



The McHenry County Major Investigation Assistance Team (MIAT) provides support to agencies in need of assistance with major investigations. Deputy Chief Fulton serves as MIAT Deputy Commander and another HDP detective is assigned to the team. In 2017, they participated in 3 meetings, 3 training sessions and 7 investigation call outs.

The **Kane County Major Crimes Task Force** provides support to agencies in Kane County in need of assistance with major investigations. Huntley responded to 3 investigation call outs this year.

Kane County SWAT provides tactical response to critical incidents. The team trains a minimum of 16 hours per month. HPD has assigned 2 officers to this team, who responded to 5 call outs this year.





The Kane County Accident Reconstruction Team (K-CART) provides high-tech, specialized teams to investigate crashes in municipalities without such capabilities. Two HPD officers are assigned to this team, including Sergeant Keane who is an Illinois State Certified Crash Reconstructionist. HPD staff responded to 1 investigation call out.

The **Illinois Law Enforcement Alarm System (ILEAS)** is a statewide police mutual aid system. Deputy Chief Mike Klunk serves as a Team Leader and 2 other officers are assigned to the team. Assigned staff attended 10 Mobile Field Force training sessions. Additionally, they attended the annual conference and 6 Team Commander meetings.



PROFESSIONAL STANDARDS

The Office of Professional Standards (OPS) is an organizational component of the police department established to investigate all Administrative Inquiries and Performance Complaints against police employees related to internal discipline, violations of Statutes, Village Ordinances and General Orders. OPS investigations serve to not only to hold employees accountable for misconduct, but also to exonerate employees from false accusations. Having a robust professional standards process is vital for employee accountability and public trust.

YOUTH PROGRAMS

Huntley Police Department 2017 Annual Report

The **School Resource Officer (SRO)** is on campus during school hours to provide positive assistance when students need individual intervention or support. The SRO is also a classroom resource for instruction on laws, safety and alcohol & drug prevention, as well as being instantly available to help the school deal with any safety or law-related issues.



LEAD the Way (Learning Effective and Assertive Decision-making) is a program developed by the Huntley Police Department to educate Leggee Elementary 5th graders on drug awareness and

life skills as they approach middle program school. The engages students with discussion, individual reflection and participation in group activities and games and provides tools and information to prepare students for the pressures and issues pre-teens face today. Topics include tobacco, marijuana, alcohol, medications, prescription bullying, peer pressure and internet safety. There were 276 graduates of the program in 2017.






Summer Teen Forum is the annual 3-day program for HHS incoming freshmen. Sponsored by HPD with the support of Lake in the Hills PD and the McHenry County Sheriff's Office, the forum is designed to establish positive law enforcement relationships with area youth and provide important information for students entering high school. Topics include bullying, dating violence, drug & alcohol awareness and risks online and in social networking. The forum had 17 attendees this year.

HPD provides **station tours** for groups such as Boy and Girl Scouts of America, preschools and daycares. In addition to seeing the police facilities and fleet, the tours often include a discussion on the role of law enforcement officers and age-appropriate safety tips. We conducted 17 tours in 2017.





To help promote bike safety, 2 **bike rodeos** were held throughout the village. These events allow children of all ages to have their bikes registered and inspected while their riding skills are tested. Officers and volunteers also discuss safe riding procedures, traffic laws and the importance of proper protective gear.





requirements. This program allows offenders to accept responsibility for their actions and receive a penalty without having a conviction on their record. A group of volunteer teens act as jurors and decide a penalty for the offender (i.e. community service, apology letters, restitution). HPD referred 16 teens in 2017.

Organized by the Huntley High School Service in Action class, we participated in the second annual friendly volleyball game at Cosman Center, called **Badges vs Backpacks**. It was a fun day that continued our positive relationship with youth in our community.





COMMUNITY PROGRAMS

The Citizen Police Academy (CPA) provides a working knowledge of the Huntley Police Department to interested citizens. In 10 weekly, interactive classes participants learn more about law enforcement and the efforts of our department. This popular program had 25 graduates for 2017.

Graduates of the CPA are eligible to join the Citizen Police Academy Alumni Association (CPAAA) which meets regularly to learn about community safety issues and provides volunteer support to the

Police Department. The CPAAA held 7 meetings and trainings throughout the year.





Community Emergency Response Team (CERT) provides critical support to first responders in emergency or disaster events. More commonly, this team is used for safety related non-emergency tasks, such as traffic control and support at special events. Membership requires training in disaster preparedness, first aid, search and rescue, fire suppression and organization. The CERT held 20 meetings and trainings throughout the year.

The **Police Explorers Program** is designed to give insight into law enforcement careers for young men and women aged 14 to 20, through hands-on activities. There were 13 Explorers throughout 2017. Neighborhood Watch is a crime prevention through community partnership program to enable officers and community members to work together to reduce crime. Watch groups provide an extra set of eyes and ears in the neighborhoods. Meetings are regularly attended by officers that are assigned to patrol that neighborhood. Coffee with a Cop is a national initiative supported by the United States Department of Justice, Office of Community Oriented Policing. These are informal gatherings of officers and citizens to discuss community issues, build relationships and drink coffee. There were 4 events held at local restaurants and neighborhood locations in 2017.



Speaker's Bureau is available on request for an officer to speak to groups. Topics include scams and fraud, pedestrian safety, and home/business security. Topics can be tailored to your group's interests and needs. 22 presentations were made in 2017

The second annual **Bike Huntley** event was a huge success. This community wide bike ride is presented by the Police Department in conjunction with the Village of Huntley and the Huntley Park District. Approximately 100 citizens came together to enjoy a fun ride and party in the Downtown Square.



National Night Out (NNO) is an annual event held on the first Tuesday of August in communities across the nation. NNO is designed to heighten crime prevention and drug awareness, as well as strengthen neighborhood spirit and foster community partnerships. We start the event each year with a friendly softball game against our friends at the Huntley Fire Protection District. An open house was held at the Police Station featuring tours, games, a dunk tank, distracted driving demonstration, and equipment display with the Huntley Fire Protection District. Officers also attended several neighborhood events that evening. The open house was very well attended and we thank everyone for their continued support of this fun community event.






TORCH RUN
