

Martin's Matters Spotlight: Election 2022

The Election Committee is pleased to announce the results of the 2022 Village of Martin's Additions Council election. Of the 627 qualified voters on the Village of Martin's Additions qualified voter roll, 329 ballot return envelopes were returned and deemed valid by the Committee, representing a 52 percent qualified voter participation rate in this year's election. This included 9 ballots that were mailed without postage were delivered to the vendor and were included in the counting. The Committee appreciates the participation and work from members of the Village and the Village Staff in addressing and working through the postage issue that arose during the Election this year.

All 329 ballot return envelopes were deemed conforming by the Committee. 328 ballots were deemed conforming, with one ballot being deemed as "Spoiled" due to an overvote, as it included votes for 3 named candidates and 2 write-in candidates (one of which was a duplication of a vote for a named candidate). That ballot was not counted.

Six ballots were hand-counted due to concerns that they might not be read by the counting machines or if they were unable to be read by the counting machines.

There are 3 spots on the Council up for election this year, meaning each ballot could cast up to 3 votes.

Additionally, there were a total of 65 write-in votes cast, with 63 write-in votes marking the "Write-In" box on the ballot and two write-in votes where a name was filled out on the appropriate line without the corresponding box filled in. Three write-in votes were ultimately deemed invalid, as they were not cast for a valid candidate, including votes for fictional characters.

RECOLLECTIONS OF PAUL WELLER

I grew up on a dairy farm near Hagerstown, Maryland. It instilled in me a life-long love of the country and agriculture, so it was only to be expected that I would earn a degree in agriculture from the state's Land Grant University and become an "aggie."

My entire professional career has been in agriculture, from writing for farm magazines upon graduation, to serving in advertising and public relations agencies in Chicago, to managing nearly a dozen agricultural associations over the years. I'm still at it – serving on the board of the King Barn Dairy MOOseum in Germantown, where we tell the historic story of Montgomery County's 500-plus dairy farms.

After five bone-chilling winters in Chicago, I gathered up Margaret and returned to the Washington, D.C. area in 1969, where I once worked. My aunt lived in Chevy Chase Village. She said: "I'll help you find a house here." It happened to be a tiny house in the town of Section Four.

One day on a plane back from Topeka, Kansas with the state's U.S. Senator James Pearson, we talked about Chevy Chase. He said: "My AA lives in Chevy Chase, in an old house on an acre of land, but it's for sale." My ears perked up. I went to the open house.

It was on a dead-end street (Raymond Street) and it was a wreck. Margaret said: "I'll never live there" After buying it in 1974, we rebuilt it and moved in. The Village's sewage plant used to be in its front yard before they hooked up to WSSC. We've been there for 48 years. It was the closest I'll probably ever get to being back in the country.

After a few years, a neighbor Wallace Jensen up the street, who had served on the Village's Citizens' Committee, suggested that I run for the Committee. He nominated me. I lost the first time around, but he did it again a bit later in 1981. I won.

There were five of us. We were offered \$45.00 a month to serve. But in 1981 there was too much work for volunteers. Case in point was street signs. Melville Place had no sign at all. An elderly neighbor lady who tried to get a cab failed because the driver couldn't find her street. I ordered a sign and crawled up on my car to mount it.

We decided to combine the five \$45.00 stipends and hire a part-time village manager. We heard about a local resident who had an advanced degree in civic affairs. We hired Jean Sperling of Shepherd Street, and the reorganization began, including incorporation papers, an array of village ordinances, and finally getting local resident Neal Potter to use his political connections to help us incorporate the Village of Martin's Additions before the state General Assembly shut the door on small incorporated jurisdictions. I served two terms on the Village Council, including as chairman. It was a busy time, but a delightful way to meet people and be of service.

We are all fortunate to have the row of commercial ventures on Brookville Road that were grandfathered in despite being in a strictly residential area. They serve us well. Some more than others. A gas station served for many years on the corner where the Village office is today. The manager knew everyone. During the early 1970's when it was nearly impossible to get gas, "Doc" would have us line our cars up on Brookville Road at night with our keys under the floor mat. The next morning, we went down to drive away with a full tank of gas.

Martin's Additions is still changing. Harry Martin would love it. The small bungalows of his era are being replaced with large, attractive "McMansions," eight on our two-block street so far. People seeking a nice place to live and raise a family seek it out. We are all proud of our village and the many personal services that it offers. Enjoy.

A Life In Public Service - Why Kindness and Caring Matter. An interview with Dr. Jeff Blander

About Jeff: Currently serves as Vice-Chair of the VMA Council. Other current volunteer and work positions include: Chief Investment Officer for the



Office of the Global AIDS Coordinator and Health Diplomacy, U.S. Department of State. Vice President-Elect for the Chevy Chase Elementary School PTA. Elected Board Member for the Wharton Club of the Nation's Capital Region.

Education: Received his Bachelor's of Science in Economics from the Wharton School as well as Doctorate and two Master's Degrees in public health from Harvard. Jeff has lived with his family in VMA since 2013, a proud Cheetah (CCES) Dad. You can often find him carpooling his daughter to school or taking out the recycling on Tuesdays.

Something your neighbors might not know: I lived in Tanzania East Africa for

almost 10 years, during that time started a private foundation to help eradicate Rheumatic Heart Disease among children. Has written several books and published a number of scientific papers, included edited a textbook on microfluidic technologies with Dr. Robert Langer, one of the co-founders of Moderna and pioneers in mRNA vaccine technology.

I was raised by my grandparents and grew up in a small close-knit beach community in the suburbs of New York City. My childhood memories include learning to ride a bike with neighbors cheering me on, digging for hidden treasures at the local park, and a town business center whose owners would greet customers on a first name basis. These same qualities of a caring, engaged, and close-knit community are what make VMA so special to my family.

Want have you learned from serving on the VMA Council? It has been almost two years since joining the VMA council. It has truly been an honor and great privilege to serve this wonderful community during this truly difficult time. Where for over a year a pandemic had stolen from us, much of what we love and held dear. At times some of the simple joys of being with friends, family and our children going to school or on playgrounds. While not always aligned with my fellow council members, I have served as an independent voice, to highlight new ideas to strengthen resident engagement impacting our entire community. 3506 Bradley Ln.

Demolition and building permit applications were submitted to the Village office. The Village issued the building permit on Dec. 9, 2021. The Wall Check

indicates the walls comply with the approved Site Plan and Village Code. Work is progressing.



The new homeowners propose to add a porch, with steps and a patio on the eastern side of the new house. They have not submitted an application to the MCDPS or the Village.

7220 Delfield St.

The applicants submitted an application to remove the existing house and build a new house. A final site visit was conducted on April 27th. The new house appears to comply with the approved site plan. The Village is closing their Building Permit and refunding the applicant's bond. The new owners said they may be moving in this week.

120 Quincy St.

The homeowner submitted plans to the County and the Village for review. The application proposes to construct several additions at the side and rear of the existing house. MCDPS issued their building permit on Jan. 5, 2022. The Village issued their permits on Feb. 6, 2022. Exterior work has begun.

162 Quincy St.

The owners have submitted a building permit application to MCDPS on May 2nd. The contractor says they are only doing interior improvements and no exterior work is planned.

3500 Raymond St.

The homeowners are considering several additions to the existing house. They have not applied to the MCDPS or to the Village.

3504 Shepherd St.

The homeowner plans on constructing an addition at the rear of the ex. house. They have not submitted an application to the MCDPS or the Village.

7200 Summit Ave.

The homeowners submitted a Variance Application for additions to the existing house. The variance was approved by the Council on July 16, 2020. The MCDPS issued their permit on April 12th. The Village issued their building permit on April 26, 2022. Work has not begun yet.

3404 Turner St.

The applicants submitted an application for a variance of the Village's minimum side yard setbacks, so they can add a second floor to the existing, non-conforming house. The Village Council approved the variance on Sept. 23, 2021. The MCDPS issued their building permit on April 17, 2021. The Village has issued the building permit on Nov. 19, 2021.



3507 Turner St.

The homeowner plans to build a new addition at the rear of the existing house. The existing house is exempt from the Village Code. However, the addition must comply with the Code's minimum side yard setback. The Village approved the variance for the side yard setback on April 6, 2022. The applicant has not applied for a permit from the County or the Village.
