2. Comply with all applicable ordinances and requirements of the Village, Montgomery County and the State of Maryland with respect to the Permit, including but not limited to all the provisions of Chapter 6 and 7 of the Village Code.

3. Save harmless the Village from any expense incurred through the failure of the Permittee, or the Permittee's agents and servants, to complete the required construction and work, or from any damages growing out of the negligence of the Permittee or the Permittee's agents or servants.

4. The Village shall retain the Security for up to the full amount thereof until Permittee promptly completes, and has accepted by the Village, all work required under the Permit and/or this Bond, or, when applicable, posts substitute security. If Permittee fails to satisfy any of the conditions of this Bond the Village has the option, but in no way is required to utilize the Security to complete the work covered by this Bond. Upon the satisfactory completion of the work as required, the Village shall return the Security or its proceeds less the amount of any claims, damages, or costs incurred by the Village in connection with this Bond.
