As you know, we are currently clearing out all the ditches and trees in conjunction with IDNR and the State of Illinois. We were approached by Woody's Waste Disposal which is down the street from where we are working, and he wants all the trees that we are taking out of that area.

Since Woody's wants all the trees that we are taking out of that area Attorney Schooley has written up a disposal removal agreement. This agreement would hold MESD harmless, and he must provide his own insurance.

Since this will in turn save MESD from having to remove and dispose of the trees therefore, we entered into an agreement with Woody's Waste & Disposal. They are taking care of all the tree disposal. We will be working on this area for the next month.

We are getting all those ditches cleaned out in Centerville Township with IDNR.

We will also have a meeting with IDNR within the month to show how much we have accomplished and where we need to be for the end result. There are other entities involved in this project since they have ditches that they belong to



An Ordinance to discuss and or approve to enter into a Cooperative

Agreement between the United States of America and Metro East Sanitary

District for Rehabilitation of a Federal Control Work. Ordinance 2021-0-005

was assigned to this document.

Attorney Schooley informed the board:

- That this agreement is attached to the ordinance. Essentially the Corp has agreed to perform approximately \$616,400 worth of improvements caused by the 2019 flood damage.
- The projects in this agreement include nine (9) damaged areas including sink holes, damaged box culverts, depressions in the levee crown and levee slides.
- The only consideration of money expected from MESD is the acquisition of temporary and permanent easements.
- MESD had Juneau review the tracks involved and they are estimating along with himself around \$3,000 to \$4,000 worth of Attorney fees in securing those easements.
- There is one at the Port Authority and we have been able to work out a good agreement with them because it involves tax district money.
