Illinois American Water Company is continuing to disconnect water for past due sewage treatment bills.

Executive Director Adler explained that Check No. 19408 to Sunbelt Rentals, Inc. is for equipment to bypass the sewer break located near the Madison Pump Station. Eventually, the Board will need to determine who is at fault, and who should pay for the repairs to the MESD forcemain. The City of Madison owns the sewer pipe under the forcemain, which may have caused the forcemain to fail.

**REPORT OF ATTORNEYS:**

Executive Director Adler introduced Britt Donoho representing the Craney Law Group. Ms. Donoho is working on two right of way issues for MESD.

**CORRESPONDENCE:**

Executive Director Adler mentioned that he received a letter from the U.S. Army Corps of Engineers stating that MESD must cease work on Stanley Ditch. Work was stopped in that area, but work is continuing a little farther down the Ditch. MESD owns the property in the new location.

President Brinza asked, "Is a legal opinion needed on the cease work order from the Corps?"

Executive Director Adler responded that the Corps is requiring MESD to obtain a 404 Permit. The Permit should not be needed to clean out the ditch. However, this will be discussed at the June 26<sup>th</sup> meeting with Tracey Kelsey from the Corps.

**OLD BUSINESS:**

Executive Director Adler asked Mr. Juneau to update the Board on the 24" forcemain failure.

Mr. Juneau reported:

I believe water, soil and mud were entering the 42" gravity sanitary sewer owned by the City of Madison. The 42" gravity sanitary sewer is below the 24" forcemain. A cavity developed, causing the 24" forcemain to fall down into the cavity. The forcemain severed and water spewed out of the forcemain causing a large hole, which aggravated the problem.

The good news is that I have been in contact with the Illinois Environmental Protection Agency (IEPA). They understand that the breaks are very close to

the levee and cannot be repaired until the Mississippi River goes down. I am in the process of preparing a response to the IEPA Violation Notice.

We will continue to monitor the level of the Mississippi River.

Executive Director Adler said he asked Juneau Associates to develop a plan to bridge the forcemain, because the 42" line owned by the City of Madison will break again.

Commissioner McCall asked, "What will it cost to repair the forcemain?"

Mr. Juneau estimated the repairs at \$100,000 to \$150,000. The cost to repair the forcemain will be less, because it is not very deep in the ground.

Executive Director Adler suggested putting a sleeve in the pipe, although it is a little more costly, it will not break again in our lifetime.

Commissioner McCall asked if a meeting has been held with the City of Madison.

Executive Director Adler stated that a meeting was held on June 19<sup>th</sup> with the Mayor of Madison and representatives from Juneau Associates. At a previous meeting, Executive Director Bob Shipley agreed to pay the costs associated with the forcemain break until an agreement can be reached.

Mr. Juneau explained that the 24" forcemain is only about 7 years old. It was put in through a twenty year loan from IEPA.

Executive Director Adler suggested putting the cost and responsibility of the sewer line repair on the agenda for the next meeting.

Mr. Juneau mentioned that there is a meeting immediately following the Board meeting today regarding the Lansdowne Special Service Facility Plan. The maps have been prepared, and the Facility Plan should be ready for submittal to IEPA within a few weeks.

Executive Director Adler requested permission to hire Scheffel Boyle to perform a transitional audit of the District's cash balances as of May 31, 2017 for an estimated cost of \$2,500 to \$3,000.

Motion Commissioner McCall; seconded Commissioner Darwin to hire Scheffel Boyle, Certified Public Accountants to perform a transitional audit of the District's cash balances as of May 31, 2017.

Executive Director Adler stated that the ditches are being cleaned and work is being done to drain Chouteau and Nameoki Townships.

Commissioner Hawkins said she is very pleased with the work being done and compliments the staff on their performance.

Executive Director Adler reported on the pump stations:

Yesterday, the Corps of Engineers issued a purchase order for Pump No. 1 at the North Pump Station. I believe they are ordering a new pump.

A second pump went out at the North Pump Station. I had the motor pulled, so the pump can be sent out for repairs, as soon as the Mississippi River goes down.

Superintendent Maeras stated that Pump #1 is needed at the North Pump Station.

Commissioner Sawicki voiced concerns that half of the pumps at the North Pump Station are not operational.

Commissioner Hawkins, "In 1986 a gate blew out of the East St. Louis Pump Station and flooded the City of East St. Louis. The voters then approved a tax increase to repair the levee system. Are the gates being maintained properly?"

Executive Director Adler replied that there is a problem with a flap gate at the East St. Louis Pump Station. However, the pump can still be used if needed.

**NEW BUSINESS:**

An Ordinance to regulate the wages of laborers, mechanics and other workers employed by the Metro East Sanitary District was presented. Number 2017-0-007 was assigned to this document.

Motion Commissioner Hawkins; seconded Commissioner Darwin to adopt Ordinance No. 2017-0-007 regarding the Prevailing Wage Act.

Executive Director Adler asked, “Would the Board prefer to continue meeting twice a month or one time a month like the County Board?”

Commissioner Hawkins voiced her concerns that there are too many important issues to only meet once a month, and that at times a special meeting maybe needed.

President Brinza said the issue should be addressed again in November of this year.

Executive Director Adler said, “Commissioner Sawicki and I attended the Southwestern Illinois Flood Prevention District meeting this morning. The Flood Prevention District plans to put a clay cap on two miles of levee. They are also repairing the 10 ½’ line owned by the City of East St. Louis that runs through the levee. They are asking the Corps of Engineers to provide financial assistance with the repair of the 10 ½’ line.”

Commissioner Hawkins asked if a member of the Southwestern Illinois Flood Prevention District could attend a MESD meeting and give an update on the current projects and finances.

The Clerk stated that she would contact Chuck Etwert the Chief Supervisor of Construction and Works for the Southwestern Illinois Flood Prevention District about attending a MESD meeting.

Commissioner Hawkins stated that the Flood Prevention District is receiving tax revenue to repair the levee system.

Executive Director Adler explained that the Flood Prevention District receives one quarter of a percent of the sales tax revenue in Madison, St. Clair and Monroe Counties. It is a perpetual tax and the goal is to achieve the 500 year level of certification with the Corps of Engineers.
