#### **REPORT OF EXECUTIVE DIRECTOR:**

Superintendent Fancher reported:

We have placed cameras in Hartford where there has been trouble with four wheelers and four wheel drives.

I am researching automatic gates for entry on our levees. You would have to have a remote for entry or a sensor on your vehicle that would open the gate automatically.

Deputy Superintendent Irby reported:

We are working on CORPS list cutting trees pushing them back.

We are also a lot of trouble with four wheelers. I have made the police aware of the problem

Superintendent Presswood reported:

Mr. Petroff has been calling me and is taking away the dirt from the dredging of Cahokia creek. He will save us time and money by taking that dirt away for us.

Foreman Hillman presented his report:

Deputy Executive Director Sawicki reported:

IDOT called and they want to build a new pump station to replace their pump station off of 255.

Illinois American Water contacted me to connect a system they have in Brooklyn. They need about a four hundred foot strip of land we own. This might be too close to our force main. We are meeting to see if we can work something out.

I also met with Charter to see about getting fiber optics to the Edison office and Madison office. The computer system we use is going to be internet based and we will need the speed.

I have looked over the Lansdowne billing calculations and they are correct. I am going to clean it up so that it is easier so that someone else can pick it up and follow it quickly.

I am working with the CORPS on the CNV procedures.

Executive Director Adler reported:

Flood Wall is moving forward, they want us to acquire all easements. Charlie Juneau is working to resolve those easements.

We are working with IEPA on the sewer relining project. We would like to accomplish this without a tax increase.

We had a big meeting on spring flood prevention.

There is also an appeal procedure in place. If they do not comply we can shut off or fine them.
