

**ORDINANCE NO. 2024-0-017**

**ORDINANCE TO REQUEST WAIVER OF FEES FOR  
ELECTRICAL TRANSMISSION LINES  
FOR THE ILLINOIS DEPARTMENT OF TRANSPORTATION  
PURSUANT TO ORDINANCE NO. 2021-0-014**

**WHEREAS**, the Metro East Sanitary District is a Sanitary District created and organized by Illinois Statute 70ILCS 2905// et. Seq; and

**WHEREAS**, the Metro East Sanitary District owns property, easements and right of ways all within its Madison County and St. Clair County jurisdictions; and

**WHEREAS**, Currently per ordinance, MESD has in effect Ordinance No. 2021-0-014 which governs uniform rates for electrical lines when entering onto, over or above, below or through MESD property, easements and rights of ways; and

**WHEREAS**, the Metro East Sanitary District Right Ordinance requires fees when electrical lines cross Metro East Sanitary District property; and

**WHEREAS**, in many instances the Metro East Sanitary District finds that taxing districts and their contractors are required to enter onto MESD property, easements and right of ways for those districts and in such instances, it is the taxing district paying fees associated with the electrical lines; and

**WHEREAS**, the Metro East Sanitary District has found that in many instances those other taxing districts interests are similar to MESD's interests or provide a direct benefit to MESD's interests; and

**WHEREAS**, the Metro East Sanitary District can consider authorizing the waiving of fees when it is of beneficial interest to both MESD and the other Taxing District, and


**WHEREAS**, the Illinois Department of Transportation has requested a waiving of the annual fee for the construction to for the 174 foot electrical line to power a sign adjacent to I-255 just north of Horseshoe Lake Road.

**NOW THEREFORE, BE IT HEREBY RESOLVED** by the Commissioners of the Metro East Sanitary District that the annual Ordinance No. 2021-0-014 fees associated with the entry onto MESD's property for purposes of construction to install the 174 foot electrical line are hereby waived as MESD finds there is a mutual interest in supporting the Illinois Department of Transportation providing traffic information to the general public on I-255. All Right of entry fees for Illinois Department of Transportation's contractors will still apply.

This Ordinance shall take effect upon passage, and may be published by the District Clerk.
