

ORDINANCE NO 2023-0-019

AN ORDINANCE PROVIDING FOR THE ANNUAL TAX LEVY FOR THE METRO EAST SANITARY DISTRICT, ST. CLAIR AND MADISON COUNTIES, ILLINOIS FOR THE FISCAL YEAR 2023, COMMENCING JANUARY 1, 2023 AND ENDING DECEMBER 31, 2023.

BE IT ORDAINED, By the Board of Commissioners of the Metro East Sanitary District of St. Clair and Madison Counties, Illinois:

SECTION 1. That there be and there is hereby levied on all taxable property within the Metro East Sanitary District, in the Counties of St. Clair and Madison, in the State of Illinois, for the fiscal year 2023, commencing January 1, 2023 and ending December 31, 2023 for the sum of FOUR MILLION, TEN THOUSAND, NINE HUNDRED THIRTY FIVE DOLLARS (\$4,010,935) which said amount shall be raised by taxation upon said property according to the value thereof as the same is assessed and equalized for state and county purposes for the year 2023 and which amount is to defray the necessary expenses of said District for the fiscal year 2023 and to provide a sum for payment of Illinois Municipal Retirement, Social Security, Auditing Fees, Liability Insurance and Tort Liability in the amounts as follows:

SECTION 2. That a tentative budget and appropriation ordinance has been prepared at the direction of the Board of Commissioners of the Metro East Sanitary District and made conveniently available to public inspection for at least thirty (30) days prior to the public hearing at 9:00 a.m., March 21, 2023, pursuant to published notice specifying the time and place where copies of the tentative budget and appropriation ordinance were available for public inspection and the time and place of the hearing.

That a public hearing was held on March 21, 2023, subsequent to published notice on February 21, 2023, and that the budget and appropriation ordinance finally adopted is substantially identical with the tentative budget and appropriation ordinance submitted at such hearing.

SECTION 3. That the District Clerk of the Metro East Sanitary District is hereby directed to file with the County Clerk of St. Clair County, a certified copy of this ordinance, and the County Clerk of St. Clair County, Illinois, is hereby directed to certify to the County Clerk of Madison County, Illinois, the rate percent which, upon the total valuation of the taxable property within said District as the same is assessed and equalized for the year 2023, will produce the amount of taxes herein above levied, and the County Clerks of said St. Clair and Madison Counties, Illinois are further directed to extend said tax against said taxable property within said District upon Collectors' Book of the said Counties of St. Clair and Madison, respectively, as provided in Section 17 of "An Act to create sanitary districts in certain localities and to drain and protect the same from overflow for sanitary purposes", as amended by the Metro East Sanitary District Act of 1974, Article 5, Section 505.1.

SECTION 4. This Ordinance shall be in full force and effect from and after its passage and approval.


