**AN ORDINANCE ESTABLISHING THE SALARY  
OF THE DISTRICT CLERK FOR THE METRO  
EAST SANITARY DISTRICT PURSUANT TO 70 ILCS 2905**

Whereas pursuant to 70 ILCS 2905/3-3 ( c), The Board of Commissioners may appoint a District Clerk who shall be the Chief Clerical Officer of the District with the District Clerk being a resident of the District.

Whereas pursuant to 70 ILCS 2905/3-5, The Board shall have the full power to pass all necessary Ordinances for the proper management and conduct of the business of the Board and of the District and assign to the District Clerk additional duties, and

Whereas, at a duly convened and organized meeting, the Board of Commissioners on January 18, 2022, appointed Amy Parkinson as District Clerk pursuant to 70 ILCS 2905/3-3(a) as well as Business Office Manager, and,

Now, Therefore, in consideration of the foregoing the Metro East Sanitary District Board of Commissioners at a duly organized meeting by vote of its members establish the Salary of the District Clerk accordingly:

- 1) The salary of the District Clerk Amy Parkinson is set at Sixty-Six Thousand Nine Hundred Fifty Dollars (\$66,950.00) per year effective January 1, 2022.
- 2) Additionally, a Stipend of Five Thousand Dollars (\$5,000.00) shall be paid for duties performed as Business Office Manager effective January 1, 2022, to be reviewed annually.
- 3) That the preambles recited above are incorporated herein and made a part hereof.
- 4) This Ordinance shall be in full force and effect on upon its passage.

Whereas pursuant to 70 ILCS 2905/3-5, The Board shall have the full power to pass all necessary Ordinances for the proper management and conduct of the business of the Board and of the District and,

Whereas, at a duly convened and recognized Board Meeting held on January 18, 2022, Executive Director Rick Fancher appointed Scott Smith as Superintendent of Madison County pursuant to 70 ILCS 2905/4-2.

Now, Therefore, in consideration of the foregoing the Metro East Sanitary District Board of Commissioners at a duly organized meeting by vote of its members establish the Salary of the Superintendent of Madison County accordingly:

Whereas pursuant to 70 ILCS 2905/4-2, The Executive Director shall appoint, when necessary, employees of the District, and,

Whereas pursuant to 70 ILCS 2905/3-5, The Board shall have the full power to pass all necessary Ordinances for the proper management and conduct of the business of the Board and of the District and,

Whereas, at a duly convened and recognized Board Meeting held on January 18, 2022, Executive Director Rick Fancher appointed Scott Hillman as Superintendent of Storm Water Maintenance and Operations pursuant to 70 ILCS 2905/4-2.

Now, Therefore, in consideration of the foregoing the Metro East Sanitary District Board of Commissioners at a duly organized meeting by vote of its members establish the Salary of the Superintendent of Storm Water Maintenance and Operations accordingly:

- 1) The salary of the Superintendent of Storm Water Maintenance and Operations Scott Hillman is set at Ninety Thousand Six Hundred Sixty-Six Dollars and 37/100 (\$90,666.37) per year, effective January 1, 2022.
- 2) Additionally, a Stipend of Five Thousand Dollars (\$5,000.00) shall be paid for duties performed as Technology Manager effective January 1, 2022, to be reviewed annually
- 3) That the preambles recited above are incorporated herein and made a part hereof.
- 4) This Ordinance shall be in full force and effect on upon its passage.

**ORDINANCE NO. 2022-0-008**

**AN ORDINANCE ESTABLISHING THE SALARY  
OF THE EXECUTIVE DIRECTOR FOR THE METRO  
EAST SANITARY DISTRICT PURSUANT TO 70 ILCS 2905**

Whereas pursuant to 70 ILCS 2905/3-3 ( c), The Board of Commissioners shall appoint an Executive Director who shall be the chief executive and administrative officer of the District with the Executive Director being a resident of the District.

Whereas pursuant to 70 ILCS 2905/3-5, The Board shall have the full power to pass all necessary Ordinances for the proper management and conduct of the business of the Board and of the District and,

Whereas pursuant to 70 ILCS 2905/4-1 Each District shall have an Executive Director who shall be appointed by, and subject to the removal by the Board;

Whereas pursuant to 70 ILCS 2905/3-3(a) the Executive Director's contract shall not: (1) be for a period of longer than one (1) year; (2) contain a provision for retroactive pay; (3) contain a provision allowing bonus pay; (4) limit termination for cause to a specific time period; (5) contain provision allowing severance pay; (6) contain provisions allowing mutual non-disparaging agreement; or (7) contain provision allowing arbitration.

Whereas, at a duly convened and organized meeting, the Board of Commissioners on January 18, 2022, appointed Rick Fancher as Executive Director pursuant to 70 ILCS 2905/3-3(a) and,

Now, Therefore, in consideration of the foregoing the Metro East Sanitary District Board of Commissioners at a duly organized meeting by vote of its members establish the Salary of the Executive Director accordingly:

- 1) The salary of the Executive Director Rick Fancher is set at Ninety-Nine Thousand Three Hundred Dollars (\$99,300.00) per year effective January 1, 2022.
- 2) That the preambles recited above are incorporated herein and made a part hereof.
- 3) This Ordinance shall be in full force and effect on upon its passage.
