Parent Liability Waiver for Pick up for the Summer 2023 (June – July 2023)

**Note*: As stated in the Rockin 66 Express Transportation Program Policies and Procedures, all children age 17 and under must have a liability waiver signed by the parent/guardian before they will be permitted to ride the transit vehicle. The Bus Driver is NOT allowed to leave their bus to walk a child into their destination.*

POLICY:

Unescorted children will only be picked up and dropped off at locations designated by the parent/guardian that sets up the schedule and signs the waiver. NO deviations will be allowed at the request of the minor. There needs to be a working phone number for the parent/guardian of the minor to be reached at all times. By signing this agreement, I agree that my unaccompanied minor will follow the rules of the Rockin 66 Express otherwise they may be removed from service, you will receive a handout on the policy.

There will be no bullying or fighting allowed on the bus. If your child is caught bullying or creating physical harm, they will be permanently removed from the services. If your child does not stay seat belted, they will be permanently removed from the services. Absolutely **NO FOOD OR DRINK** is allowed on the bus due to severe allergy problems from other passengers.

Your child needs to be at the bus stop at the time that you have them scheduled for. If your child is not out at that time the driver will have to leave. The driver/dispatcher will **NOT** be able to call parents if their child is not at the bus stop. The driver will not be able to deviate from the original drop off location unless the parents make prior arrangements at least 1 hour in advance.

After-School Transport: We begin taking reservations for afterschool transport July 1 and are normally booked up by the time school starts. Staffing limitations prohibit us from serving every school in the district. Reservations are made for the entire school year. These reservations can only be taken from those ineligible to utilize the public-school bus system. Please make sure your child is on time to his/her pick up. No child will be able to ride without a parental consent form. Parents are required to inform dispatch if their child is not going to be riding the bus, **every time** via text message or phone call to dispatch. There is a no-show policy (see handout) that could result in suspension of services for your child. This is public transportation and there will be times when other adults will be riding with your child.
