Minutes of the Community Improvement Corporation of Milford Annual Meeting Tuesday, May 10, 2022 – 3:30 p.m. to 5:05 p.m.

The Community Improvement Corporation of Milford (C.I.C.) Board met in City Council Chambers at the Milford Municipal Building, 745 Center Street, on Friday, May 10, 2022 at 3:30 p.m. Ralph Vilardo called the meeting to order. The following Trustees were in attendance: Ralph Vilardo, Laurie Howland, Lou Bishop, Gary Green, Lisa Evans, Mike Minniear, and Pat Wirthlin. Ms. Wirthlin made a motion to excuse Trustee Michael Doss from the meeting. Ms. Evans seconded. The members unanimously agreed.

#### **Minutes**

Ms. Howland moved to approve the Minutes from the April 8, 2022 C.I.C. Meeting of the Board of Trustees. Mr. Bishop seconded. All other members unanimously agreed.

#### Discussion: Resignation of Pam Holbrook – Appointment of New Board Member(s)

Mr. Vilardo moved to appoint Christine Celsor, the City's Planning and Community Development Coordinator, to the Board. Mr. Minniear seconded. All unanimously agreed. The Trustees discussed filling the next Board seat with an individual who has a background in economic development. The Board agreed to ask Mike Green if he would be interested in joining the C.I.C. Board due to Mr. Green's knowledge and skillset in this area.

# Discussion: Sale / Use / Development of Property - 25 Main

The Trustees reviewed two properties as potential investors in 25 Main -- Kirk Jewelers and Vision Realty. (Council forwarded these Requests for Proposal to the C.I.C. for further vetting yet left the process open-ended – the C.I.C. is free to entertain or solicit additional options.) Mr. Vilardo emphasized that any new owner will have the envious advantage of being located within the City's Community Reinvestment Area (C.R.A.) – a vastly understated benefit. Mr. Vilardo and Ms. Howland pointed out that once the Distillery opens for business, the property value could markedly increase and drive people to want to live in the area ... it might be best to wait that out. Mr. Minniear allowed as to

how the City purchased the property for \$540,000 which was below its appraised value of \$675,000 ... the City would need to justify selling the property for less than what it paid (unless its new use is otherwise beneficial to the City). Ms. Evans offered that most on Council are interested in mixed-use with right of final approval of the developer or development. Mr. Bishop emphasized, and all agreed that maintaining and exploring some manner of parking is important. The Board agreed to spend time exploring other developers and developments.

#### **Adjournment**

The meeting adjourned at 5:05 p.m. with a motion from Mr. Minniear, a second from Ms. Howland, and unanimous agreement from the Board.
