The Council of the City of Milford met in Council Chambers at 745 Center Street at 7:00pm on January 2,

Mayor Evans called the meeting to order the Pledge of Allegiance and a Moment of Silence. The Presentation of Colors by the Milford Community Fire Department Honor Guard and the City of Milford Police Department Honor Guard.

Roll Call

Present: Lisa Evans, Kristopher Parrish, Janet Cooper, Kim Chamberland, Brad Price, Ralph Vilardo Jr. and Mark Thompson Also present was City Manager, Michael Doss, and Law Director Bryan E. Pacheco. The public was able to view via Facebook live and via ICRC TV broadcast.

Swearing in Ceremony: Law Director Bryan E. Pacheco swore in the newly elected council members: Kristopher Parrish, Brad Price, Ralph Vilardo Jr and Mark Thompson.

Election of Mayor: Law Director - Mr. Pacheco stated that we needed a motion to appoint the Mayor. Mr. Parrish made a motion to nominate Lisa Evans as Mayor. Seconded by Ms. Chamberland. No other nominations were made for position of Mayor. Voice vote: All voted yes/aye. A motion to appoint Lisa Evans as Mayor by acclimation. Lisa Evans was then sworn in by Mr. Pacheco as Mayor of the City of Milford. Mayor Lisa Evans opened the floor for nominations of Vice Mayor. Law Director Bryan Pacheco stated that we need a motion to appoint a Vice Mayor and a second to the motion if this is the pleasure of council. Ms. Cooper nominated Kristopher Parrish. Seconded by Ms. Chamberland. Mr. Pacheco asked if there was any discussion on the motion. Brad Price nominated Ralph Vilardo. Seconded by Ralph Vilardo. Mr. Pacheco stated that we have a properly made motion. We have a second of the motion with respect to Mr. Parrish. Unless there is a motion to table, that motion is properly heard. There cannot be another motion to nominate someone else. There can be a motion to table that. In which case it would table it and then you could continue that discussion. But right now, there is a motion and a second to have Mr. Parrish be the Vice Mayor. Again, there could be a motion to table, but that would require four votes and then would table that motion. Mayor Evans asked if there was a motion to table? Otherwise, we will vote for Mr. Parrish. Mr. Pacheco said that was correct. Again, to be clear, the only thing that could stop the motion at this particular point that was made, and properly seconded, with discussion was the motion to appoint Mr. Parrish. If there is a motion to table, which I did not hear, it is proper to vote now for Mr. Parrish. Mr. Vilardo stated that just so he is clear, there is a second motion, does that get tabled? Mr. Pacheco responded that it has to be tabled to the original motion, cannot be two motions on the table. The motion to stop the current motion would be up, for Mr. Parrish since it was properly seconded. There could be discussion or there could be a motion to table that motion. And if that is tabled, then there could be any other motion put forward in which case, the other motion could be properly considered. But right now, unless there is a motion to table, which is properly carried by council, there will be a vote on Mr. Parrish. Mr. Vilardo asked if it would be just a yes or no vote. Mr. Pacheco asked, on the table? Mr. Vilardo stated, no, on Mr. Parrish. Mr. Pacheco said, yes, it would require a majority vote. Clerk of Council called the roll. All yes Mr. Vilardo no. Kristopher Parrish was then sworn in by Mr. Pacheco as Vice Mayor of the City of Milford.

Once approved, bidding is expected to commence in March. Ohio Department of Development Grants – The City is working with our engineers on two grant applications for sanitary sewer. The two grant applications will be for sanitary sewer lining for the Clertoma subdivision and a UV system for the treatment facility. The deadline for grant submittals is January 17. City Hall External Repair Update – Trisco Construction Services is currently working on repairs to the exterior of City Hall. Most of the project is expected to be completed this winter with the final painting in early spring 2024. Five Points Landing Park Landscape – Evans Landscaping has started the landscaping at Five Points Landing Park. Rock boulders/formations are being installed this week. Former Marathon Station/BUSTR – Contractors with Terracon will install two additional monitoring wells on Locust Street in the next few weeks.
