Mr. Pacheco replied that he has worked on information for Blue Ash regarding Short Term Rentals and stated some rules that they now have in place and other options that are available to legislate. Also discussed Short Term Rental differences between the residential and business compatibility of the neighborhoods. Council has to provide the decisions to the public and his job is to provide council with the options.

Ms. Evans asked if he has had any experience with Charter Revision process

Mr. Pacheco replied that yes and he is actually going through this in Deer Park, and it is on the ballot. He discussed the processed that he used.

Mr. Redman asked for him to share some of his personal experience with some notable litigation that was specific to local government.
