The City anticipates a scheduled completion of the project by Memorial Day weekend 2023. Garfield Avenue Sanitary Sewer Update – The developer's contractor needs to tie in the sanitary sewer from the street line to the development site and raise the manhole. Garfield Avenue will remain closed for the remainder of December. Proposed Multi-Family Development – The City is in discussions with a developer to develop multi-family units. The developer is requesting a possible TIF to defer some of the property tax expenditures for the project. 2023 CDBG Program – Clermont County is now accepting Community Development Block Grant applications. The City is exploring several options for projects including the expansion of the existing walking path at Riverside Park or additional amenities at Five Points Landing Park. Applications are due to the County by February 17.
