The City of Milford has **mandatory registration** by paper form or online at www.ritaohio.com using "MyAccount".

The City of Milford has an earnings **tax of one percent.**

The tax applies to all residents, who live in the City of Milford.

The tax applies to all non-residents, who work, operate a business, perform services, or earn income within the City of Milford.

The tax applies to any business that operates, works, performs services, or earns income within the City of Milford.

Tax must be paid regardless of age or level of income.

No credit allowed for taxes paid to another municipality, joint economic development district (JEDD), joint economic development zone (JEDZ), or Enterprise Zone (ENTZ).

The Regional Income Tax Agency (RITA) has been contracted to assist in the administration, collection, and enforcement of the Milford Income Tax.

MILFORD JOINT ECONOMIC DEVELOPMENT DISTRICT (J.E.D.D.) INCOME TAX

Milford JEDD Income Tax follows the provisions indicated in the Milford Income Tax Ordinance Chapter 182. For information, see <https://www.ritaohio.com/Municipalities/Home/MemberPage?id=513>.

There are **7** Milford JEDD areas and each area is comprised of several designated parcels in Union Township. The JEDDs have **mandatory registration** by paper form or online at www.ritaohio.com using "MyAccount". (Please verify the address location in order for filings to be applied to the correct Milford JEDD.)

The JEDDs have an earnings **tax of one percent**.

The tax applies to all residents, who live in a Milford JEDD.

The tax applies to all non-residents, who work, operate a business, perform services, or earn income within a Milford JEDD.

The tax applies to any business that operates, works, performs services, or earns income within a Milford JEDD.

Tax must be paid regardless of age or level of income.

No credit allowed for taxes paid to another municipality, joint economic development district (JEDD), joint economic development zone (JEDZ), or Enterprise Zone (ENTZ).

The Regional Income Tax Agency (RITA) has been contracted to assist in the administration, collection, and enforcement of any Milford JEDD Income Tax.

MILFORD TRANSIENT OCCUPANCY TAX

The Milford Transient Occupancy Tax follows the provisions indicated in the Milford Transient Occupancy Tax Ordinance Chapter 185. For information, see

Mandatory Milford Transient Occupancy Tax Registration required.

Transient Occupancy Tax rate is **3 percent** on all transactions by which lodging is furnished to transient guests by an establishment.

The returns and payments shall be remitted to the Milford Tax Department at 745 Center Street, Suite 220, Milford, OH 45150

MILFORD ADMISSION TAX

The Milford Admission Tax follows the provisions indicated in the Milford Admission Tax Ordinance Chapter 187. For information, see https://codelibrary.amlegal.com/codes/milford/latest/milford_oh/0-0-0-4474#JD_187 .

Milford Admission Tax Mandatory Registration is required.

Milford Admission Tax rate is **three percent** on the amounts received for admission to any cinema within the city limits. Returns and payments are due on or before the last day of the month following the close of the month collected. The returns and payments are remitted to the Milford Tax Department at 745 Center Street, Suite 220, Milford, OH 45150
