

Safety Services Committee Meeting Minutes
January 12, 2018

Called to Order: 4:30 p.m.

Present: Vice-Mayor Brewer, Ed Brady, Sandy Russell

Staff: Michael Doss, City Manager; Police Chief Jamey Mills; Administrative Sergeant Sean Mahan, Lori Pegg, Community Services Manager.

The committee has chosen Sandy Russell as the chairperson.

Police Vehicles

Chief Mills presented information on a 2018 Tahoe replacement patrol vehicle. The Chief is requesting to make the following purchases: a Chevrolet Tahoe from Tim Lally Chevrolet in the amount of \$47,831 and an upfit from Camp Safety in the amount of \$13,792.25.

This is a \$10,000 under the sticker price based on the state bid. They will be replacing one of the Tahoe's purchased in 2011. Most agencies replace their vehicles within 5-6 years. The chargers were very bad on maintenance and the Tahoe's are lasting much longer. The new cruiser will also include a in car camera system from Watch Guard in the amount of \$5819.00

The Committee agreed to make a motion to draft an ordinance authorizing the purchase of a 2018 Chevrolet Tahoe from Tim Lally Chevrolet in the amount of \$47,831 and an upfit from Camp Safety for \$13,792.2

Purchase of Replacement Body Armor

Chief Mills presented a quote from Galls for replacement body armor for those that have expired after 5 years of use. The fibers start to separate on the Kevlar and the industry standard is five years. Chief Mills has secured a grant for 40% of the cost.

The Committee agreed to make a motion to draft an ordinance authorizing the purchase of body armor from Galls in the amount of \$15,947.87.

Purchase of Replacement Tasers

Chief Mills presented a quote from Vance's Law Enforcement for replacement tasers in the amount of \$9152.90. The current tasers are 5 years old and are at their maximum lifespan. We are purchasing 8 tasers and those that are over five years will be decommissioned. The officers share tasers. The tasers were not utilized at all last year and once the time before. If it is used the taser goes into the property room and is not used again after it has been downloaded. We do maintain 8 even though 4 officers are on duty at a time. The four additional are used when there are extra details or additional officers on duty.

The Committee agreed to make a motion to draft an ordinance authorizing the purchase of replacement Tasers from Vance's Law Enforcement in the amount of \$9152.90.

There being no further business, the meeting adjourned at 4:30
