Councilmember Brownell would like to have a review of the personnel policy and have a new "three strikes and you are out" standard implemented. He also wanted to know who from the City, was overseeing the funds from Community Development with regard to the budget, the director's salary and shareholder's contributions. Baethke informed Brownell that MCD works with a tight budget based on funds received from the City, Water Dept., Gas Dept., Electric Dept., as well as other business and private sources. Many of these same entities are also shareholders for MCD and play an essential part of the success Baethke & MCD have been able to accomplish, including the opening of Zuma Zoo Daycare and NuCara Pharmacy. Mayor Simpson inquired how Baethke is able to allocate her time as far as performing MCD work and her role as Director of Finance. McCaslen, the Secretary/Treasurer of the MCD Board, explained to the Council that the above-mentioned openings would have never had happened if Baethke had not had the lead role as MCD Director.

Resolution #18-03-04: Resolution Authorizing the Director of Finance to make the Attached Adjustments & Transfers to the Appropriate Fund for the Fiscal Year Ending June 30, 2018 for the City of Montezuma, Iowa. Councilmember Brownell made the motion to approve the resolution with a second from Councilmember Willrich. Ayes: all, Nays: none.

Steve Short had inquired about the possibility of reserving another spot on the south side of the Poweshiek County Courthouse for handicap parking. There is currently one on the north side and two on the south, which is the same side that has the elevator right inside the door. Mayor Simpson said he would talk to Steve to find out exactly where they were proposing the new spaces be located.

EMT personnel was brought up again. Brownells, Inc. has several employees interested in acquiring EMT certification. Only two are from Montezuma, all others come from out of town to work at Brownells. Having more members of the ambulance crew would reduce the issue with the same few EMT'S on staff now going on all of the calls. Frank Brownell stated Brownells would pay the expense of the EMT training for their employees.

Legion Post #169 holds its meetings in the northeast part of the Memorial Hall. At this time, they do not hold a liquor license. The City has been advised by the city attorney that any City owned property that is involved in serving alcohol be required to provide dram shop and liability insurance coverage covering the City of Montezuma. This is also the request of the City's insurance carrier. The City needs to have insurance coverage to provide coverage for any lawsuit that may arise. The Council requested that a letter be drafted and sent to the legion members in explanation on how crucial it is that the correct insurance coverage is being carried.

Ewing addressed the issue on how many trees that have been cut down in the West City Park. He presented the Council with prices and descriptions of several different types of trees in order to pick the best one for that particular area. Mayor Simpson has much knowledge with this type of material and even suggested that the City could see about incorporating the planting of the new trees as part of Monte Pride or Arbor Day. Councilmember Bolen made a motion to allow up to \$1500 from the parks budget to purchase and replanting the new trees. A second was made by Councilmember Duffy. Ayes: all, Nays: none.

McCaslen informed the Council on the continuing plans regarding RAGRAI. Road closures and vendor permit fees were a few of the items discussed. The committee will meet again after the initial state-wide RAGBRAI meeting on April 7th.

The press release for the new housing incentives has been drawn up by Baethke and is ready to go. It lays out the explanation behind the incentives in the hopes to spark new home construction. The information will also go out to local developers, contractors and realtors. Baethke has also put all the information on the City's website, www.montezumaiowa.org.

A question on the property lines and pins for the South Diamond Development was brought up due to the new houses looking to get ready to break ground this spring. Warden explained that the pins had been removed when the electrical pedestals were installed. Councilmember Brownell wants Clapsaddle-Garber & Associates to come and re-survey the lots and charge the Montezuma Light Plant the fees.

It was brought to the attention of the Council that the lot pins at the South Diamond Subdivision have been located and were never removed as originally thought when installing electrical pedestals.

The Montezuma United Methodist Church sent the Council a request to designate two more handicap parking spaces on the east side of the church. The Council decided that it would benefit the rest of the City to have the Church get some kind of signage that they could put out on Sundays, funerals, wedding days, etc., in order to keep those spaces open for regular parking on regular days of business.

Andy Erselius, A&E Realty, brought the idea of marketing the South Diamond Subdivision to the Council. He was suggesting an open listing format in order to keep commissions down. Bryan Realty owner, Raenelle Bryan, informed the Council that the Multiple Listing Services does not allow this. Each realtor can put one lot on their own personal website and can market the subdivision as a whole. This in turn will allow the realtors to get the word out about the available lots in the subdivision. The City itself can list the lots on Zillow or Trulia which will also amp the exposure.

McCaslen, Co-Chair of the 2018 RAGBRAI Committee, presented the Council with a resolution and vendor permit to review. Councilmember Brownell wanted the hours of operations and mailing address added to the vendor permit and the shut-down hours specified on the resolution. A motion to approve the resolution and vendor permit pending noted corrections was made by Councilmember Brownell. A second was made by Councilmember Willrich. Ayes: all, Nays: none.

The property located at 605 East Main Street, a rental owned by Richard Lyddon, was the next topic of discussion. This property has had multiple inspections and has not been repaired to the requirement of the Safe Building inspector and the City. The Council was provided the latest report on the issues that are still out of compliance and the main concern with these problems is the safety of the renters that may want to move in. Councilmember Duffy made the motion to proceed with condemnation procedures with a second by Councilmember J. Bolen. Ayes: all, Nays: none.

The American Legion Post #169 holds their meeting on the northeast side of the Memorial Hall. When the City was in the process of having an insurance review, it was brought to their attention that there is no coverage for the Legion to be serving alcohol while conducting their meetings or fish fries. This issue puts the City in a liability bind in case there were to ever be a claim. Councilmember Duffy made the motion to have Councilmember Brownell talk to the Ron Hensel, Commander, to explain the position the City is in insurance wise and how to resolve the need for the Legion's dram shop insurance. Councilmember J. Bolen seconded the motion. Ayes: all, Nays: none.

Travis Johannes of the Montezuma Gas Department was present to answer questions regarding the I.M.A.U. Emergency Plan and O&M Plan Revisions. Councilmember Brownell questioned as to where

the supporting documents were to see what changes were being made. Johannes explained the I.A.M.U. plan is a large document to read over and the Council had already approved it at a previous meeting. The Mayor asked that the entire document be emailed out to the Council for their reference. Councilmember J. Bolen motioned to have the I.A.M.U. Emergency and O&M Plan revisions be approved. A second was made by Councilmember Duffy. Ayes: Willrich, J. Bolen & Duffy. Nays: Brownell. The motion passed.

Councilmember Brownell is requesting that a thorough review of the adopted employee handbook take place as he wants to make sure all employees have not only read the document, but also understand it. The Water Department adopted the handbook but the Electric Department has not. The Council would like to have go over the document during council meetings and once that has been done, hold a work-session with employees to go over the handbook with them as well. A meeting including the Water Board and Electric Board will be scheduled at a later date to discuss the handbook.

Jacki Bolen expressed concern for Manestreet Hair Designers, as the City goes through with the rehab of 4th Street. There is a coal room under the sidewalk along the east side of the sidewalk between Manestreet Hair Designers and The Grind. Bolen as well as co-owner Niki Latcham, are worried that will all the work being done on that street that it could cause that coal room to cave. A similar incident occurred across the street near Montezuma State Bank. Baethke said she would send an email out to Veenstra & Kim, the engineers in charge of this project and have them take a look at the coal room to see if any precautions need to take place.

Another concern that came up is the logistics of North 2nd Street and the east/west functioning alleyway that it connects to. There has been some concern that they do not connect. The Council discussed the possibilities on the changes that could be made if it was determined to not be an alley.

The Mayor asked Mark Ewing to have the City's pasture fence put back into place as the renter is wanting to bring in his cattle soon. B&B Tree Service had removed a bunch of debris from John Kercheval's timber by placing the brush on the City pasture. It was decided by the Council that B&B will have to find an alternate route to get the trees out of the timber since the cows would be in the pasture and they will not be able to pile the debris in the pasture as well.

A motion to adjourn was made by Councilmember Willrich, with a second by Councilmember J. Bolen. Ayes: all, Nays: none.

Veenstra and Kimm put together a proposal for the engineering services regarding the Sanitary Sewer Facility Plan. This will be used as part of and necessary for a Community Development Block Grant application that would address the replacement of the sewer along this stretch of street as well as the reconstruction of the pavement. Councilmember Duffy made the motion to table this issue until more information becomes available. Councilmember Willrich seconded the motion. Ayes: all, Nays: none.

Montezuma Community Development Director, Whitney Baethke, gave an update to the Council on the 150th celebration plans. She received word from the DOT that Main Street could be closed on Saturday, August 25th for the festivities. Assorted t-shirts and commemorative mugs have been ordered, delivered and are ready for purchase. The MCD Board will meet shortly and put together a marketing strategy for posters and such. The school will be hosting a home football game that Friday night as well as planning their Hall of Fame Induction that same weekend.

Councilmember J. Bolen made a motion to table the review of the Employee Handbook until the council can review it and bring their concerns to the following meeting. A second was made by Councilmember C. Bolen. Ayes: all, Nays: none.

Montezuma's CLG (Certified Local Government) group came to ask the Council for some supporting funds to help with the paving project for Bonham Trail. LL Pelling Co., has given the CLG a proposal to seal-coat the trail. The estimated cost is \$25,081.80. VerMeer stated that there are some funds in an account available for use on this project but will still come up short. Poweshiek County donated \$50,000 to the City of Grinnell for updating and work done to their Central Park area so the Council suggested approaching the Supervisors as well. The CLG is also looking into upgrading the benches along the trail and stated that some resources have been donated to accomplish this task. A bridge connecting the South Diamond Subdivision to the trail is also an idea along with better signage about no motor vehicles allowed on the trail. For the past two years students, teachers, community volunteers and city staff have helped bring life back to the trail during Monte Pride Day. Truckloads of debris have been cut back and removed to make the trail more attractive to the public. Councilmember Brownell made the motion to have the City contribute \$7500 to the CLG for the Bonham Trail Project.

Councilmember C. Bolen seconded the motion. Ayes: all, Nays: none. Councilmember Duffy also stated that he would like to see the County be able to match the City's funds to this plan.

Poweshiek County is going to be replacing some of the worn sidewalk on the east side of the square. The Council committed \$2500 previously to help with this repair/replacement work.

McCaslen gave an update of the houses that have now been put into the court system for property maintenance violations. The Council expressed that no extensions will be allowed at this point. Safety is the number one concern for the rental properties that are in this process.

Councilmember Brownell informed the Council that he had spoken to a member of the Legion Post #169 about the issue of them not being properly insured when serving alcohol at their meetings and social gatherings. Not having insurance is not an option and the Council will be setting a deadline at the next meeting to determine when the insurance must be purchased.

Several members of the community addressed the Council wishing to use the West and East Park basketball courts to play pickleball. Bryce Vanderkamp explained that the group has been playing at the Family Center but would like to find a spot that would allow them to play outside. He explained the net being used is temporary but would like to ask the Council's permission to paint game-lines on the basketball court. Councilmember Willrich made the motion to approve the painting along with a second from Councilmember Duffy. Ayes: all, Nays: none.

Michael Hart, representing Northland Securities was present to go over financing for the upcoming 4th Street Project. After the bids for the project have been received, he will make any necessary adjustments to the GO Bonds in order to make sure they meet the City's needs. Hart provided figures compiling numbers to show the Council how much the payment will be after borrowing the money for the street construction making budgeting easier. These bonds cannot be prepaid early and Hart stated that the local financial institutions will have first priority to purchase the bonds.

Resolution #18-05-01: Resolution Authorizing the use of a Preliminary Official Statement in Connection with the Sale of Bonds Thereunder. Councilmember Duffy made the motion to approve this resolution with a second from Councilmember C. Bolen. Ayes: all, Nays: none.

Resolution #18-05-02: Resolution Setting the Time and Place for Public Hearing Concerning the Budget Amendment for Fiscal Year 2018 for the City of Montezuma, Iowa. The public hearing was set for Monday, May 21, 2018 and Councilmember C. Bolen made to motion to accept this. A second was made by Councilmember J. Bolen. Ayes: all, Nays: none.

The Preliminary Plat for South Diamond Addition Part Two to Montezuma, Iowa was next on the agenda. Motion to approve this plat and to waive the subdivision platting fees was made by Councilmember Willrich and seconded by Councilmember J. Bolen. Ayes: all, Nays: none. The abstracts will now be brought up to date as well as having a title opinion done.

Top Brave, LLC submitted an offer to purchase lots #12 & #13 in the South Diamond Addition. Councilmember J. Bolen made the motion to accept the offer of \$5000 per lot. Councilmember Duffy seconded the motion. Ernest money in the amount of \$500 per lot was also put down by Top Brave.

A motion to table the employee handbook review was made by J. Bolen and seconded by Councilmember Duffy. Ayes: all, Nays: none.

Ewing asked the Mayor what kind of timeline he was looking at LL Pelling seal coat the selected streets this summer. Mayor Simpson expressed that he would prefer to have them done when the

weather is warmer in order to have the tar set-up better. The 4th Street Project, July 4th, RAGBRAI and 150th Celebration activities are playing a role in the planning of getting the streets sealed.

The Council discussed the deadline of the American Legion Post needing proof of insurance by June 1, 2018. McCaslen will make sure a member of the Legion knows of this deadline.

Other items discussed included inquiring if any more progress had been made on having the Montezuma Fire Department become their own 501(C)3. This would make their funds separate from the City's General Fund. Several Councilmembers have driven down South Diamond Drive and have expressed their concerns regarding the newer street not being smooth. Mayor Simpson advised Ewing to make sure and get the cracks sealed so that water can't get under the street, freeze and then allow it to crack even more.

The Poweshiek County Supervisors allocated \$3,400 to the Bonham Trail Paving Project.

Mayor Simpson asked the Council to consider having the City charge for mowing the lots at the South Diamond Addition once they have been purchased. The City will continue to mow the lots still owned by the City but will determine an amount to be charged for any lots purchased but still needing to be mowed by the City.

This would limit the changes that are available to be made. Chevy currently does not offer the longer wheel base compared to Ford. New Sharon Ambulance recently purchased their new rig from Foster Coach and is pleased so far. After some discussion a motion was made by Councilmember J. Bolen to allow the Montezuma Fire Department to spend \$170,164 on a new ambulance with the trade-in offer to be determined for rig #91 and if the Fire Department wants to

purchase 91, they will be able to buy it for \$1.00 more that the trade-in offer. This motion was seconded by Councilmember C. Bolen. Ayes: all, Nays: none.

The Little League brought the Council a proposal to set up a movable batting cage along the fence line at the City's East Park. Players, coaches and parents plan on having a stand when RAGBRAI comes through Montezuma in order to continue to raise funds to purchase like items in the future. Councilmember C. Bolen made the motion to approve with a second by Councilmember Brownell. Ayes: all, Nays: none.

Councilmember Brownell made the motion to table discussion on the Employee Handbook Review until a later date. Councilmember C. Bolen seconded the motion. Ayes: all, Nays: none.

Ewing informed the Council that L.L. Pelling has finished seal-coating the mapped-out roads for this summer and is ready to move on to paving Bonham Trail.

Baethke brought to the Council's attention the idea of erecting a "tiny house" on a lot within the city limits. The city attorney instructed the Council that the ordinance states that the structure "shall have a minimum dimension of twenty-two (22) feet measured at the narrowest point of such dwelling." A motion to table discussion until more information had been collected was made by Councilmember Brownell with a second from Councilmember C. Bolen. Ayes: all, Nays: none.

The sidewalk running along the southside of East Liberty Street has been broken up by the trees. Aaron Longfellow owns property on this stretch of street and has removed his banged-up sidewalk with the hopes that the Council will allow him to fill it in the area with dirt and seed it. He is afraid that if he spends the money to replace the sidewalk, he will be dealing with this issue again. Matt Simpson also voiced his concern regarding his sidewalk on the north side of his property. It is having the same issues with the trees. The decision was to go ahead and vacate the sidewalk and have the empty space filled in and seeded.

Mayor Simpson was pleased to inform the Council that there will be a major addition to the City's East Park. He was contacted by the Mid-American rep and was excited to hear that they wanted to say thank-you to the City of Montezuma for putting up with all of the noise, traffic and other issues as they have been erecting the wind turbines. They gave him a proposel for a new playground layout to have approved. Councilmember J. Bolen motioned to accept the proposal with a second by Councilmember Brownell. Ayes: all, Nays: none.

A request to allow Streetrod Golf Cars to relocate to Grinnell was brought to the Council. The move would require the City of Montezuma to sign a release since Grinnell plans on using TIFF designated dollars for the relocation. Streetrod already has a new location site ready for production. More information will be brought to the next meeting by Baethke.

Mark Floden addressed the Street and Sewer Departments asking them to come take a look a problem with water not draining off his property due to the way the road has been built-up. Ewing and Warden said they would go take a look at the issue and see what can be resolved.
