This application is to be used for families as well as individuals. Please give the ages of all children, as well as their last names if other than the name of the applicant. Family members on the same membership card are restricted to those members of the immediate family, regardless of age, who reside in the same household. In order to insure fairness, this will be monitored carefully and the Township reserves the right to question and deny and/or revoke any membership for falsifying this information.

Children under the age of sixteen (16) must be accompanied by an adult.

Season tickets may be purchased at the Recreation Center, Monday-Friday, between the hours of 8:30am and 4:30pm. If mailing your application, please include a self-addressed, stamped envelope so that your tickets can be mailed back to you, otherwise your tickets may be picked up at the pool on or after opening day. Do not send cash through the mail.

If you reserve a picnic pavilion and wish to go swimming your entire group will receive \$1.00 off the daily rate fee. In order to receive the discounted rate, you must present a copy of the pavilion reservation form to the front desk. This discount only applies to the day of your rental.
