Please find attached the 2010 Annual Report for the Pekin Police Department. The Annual Report provides a wealth of information on the activities, outcomes and priorities of the Police Department.

While last year's report highlighted on *change*, it turns out that 2009 was only the first year of a one-two punch of change. 2010 ended with a number of retirements of key positions both inside the Police Department and outside of it. 2010 saw the retirements of Chief Ted Miller, Deputy Chief John Ghidina and Lieutenant Tim Gleason. Outside the Police Department, other city department heads retired, as did the City Manager. The retirements in 2010 even extended as far as our K9, Aslan. I am pleased to report that despite massive change, the Police Department not only continued on, but continued to improve.

As our community continued to struggle through an economic recession, reported crime fell by 10.5% and calls for service fell by 4%. Traffic crashes remained flat, but injury accidents fell by 22%.

Your police department remains committed to our mission, which is to protect life, human rights and property through an effective, proactive partnership with the community. More than ever we need the support and involvement of the community, and more than ever we will work to engage them.








2006 - 2010 Arrests

Percent of Non-Criminal Cases Closed





2010 Crime Prevention Office

Crime Prevention: The Pekin Police Department is actively involved with a Crime Prevention program, in which our initiative is to assist the community in the reduction of crime occurring against our citizens. The Pekin Police Department appoints a sworn police officer to assist the city in our efforts of crime prevention.

Knowledge is power, and by learning simple crime prevention techniques and employing them can dramatically decrease the chances of being a victim of crime. An active community is the best partner the Pekin Police Department can have when it comes to fighting crime. By teaching and promoting crime prevention techniques, our objective is to show that criminal activities will not be tolerated in our neighborhoods.

National Night Out Against Crime: The 2010 National Night Out Against Crime was attended by over 700 people. There were approximately 20 local service agencies in attendance. The event was held at the Avantis Dome.

The activities for the evening included multiple inflatable rides, emergency vehicle displays, TCSD motorcycle unit, bike giveaway, free food and drinks, DJ service, and prize giveaways.

Shop With a Hero: The Shop With a Hero event had \$2,300 donated to allow 31 children to be able to participate.

Crime Stoppers: Pekin Police Department is part of the Greater Peoria Area Crime Stoppers Program. Callers remain anonymous and can give information to either the Peoria or Pekin number. Felony crime re-enactments are put on radio and television and people are given cash rewards if information they provide leads to an arrest or indictment. Crime of the Week highlights a major or felony crime.

Annual Training Summary

Pekin Police Department logged approximately 2300 hours of training, both internally and externally, in more than ten substantive areas during 2010. Some of the highlights include:

- Five command officers completed and internal affairs investigations course
- One officer was trained and certified as a cellular phone forensic examiner
- Eight officers attended training on combating gangs in our community
- One officer was certified as a crime scene investigator
- Five officers attended a variety of interview and interrogation
- Two officers attended a variety of death investigations courses
- Seven officers attended a variety of DUI enforcement courses
- Both departmental K-9 officer and K9 supervisor attended K9 legal update and tactical training
- Three officers attended a variety of crimes against children training and one was certified as a forensic interviewer of children
- Three command officers attended a variety of leadership training

The Pekin Police Department has continued to work diligently at meeting its training goals for 2010. The Department was able to certify a crime scene investigator and continue technological training with computers and cellular devices. Our goals of 2011 include:

- Continue advanced training in computer and cellular forensics to better able our officers to investigate these types of crime
- Training and certification of additional juvenile officers
- Send additional command staff through The School of Police Staff and Command




