Deputy Police Chief Kaminski submitted probationary reports for officer #5141 that he received this morning. There are no issues to report. The probationary officer at the academy #5142 is scheduled to graduate from the academy September 11, 2015.

Commissioner Franks asked about checking on pricing and availability of other providers for the preemployment physicals. Per Fire Chief Nelson, other providers in the area don't have the capacity or personnel necessary to perform some of the aspects of the physical examinations.

It was noted by Fire Chief Nelson that the fire department original appointment testing worked out great using the high school facilities. For the future, he intends to have a discussion with the high school regarding the charges for the use of their facilities. The fire chief will also make contact with Steve Hale with Resource Management regarding all available options for future written examinations.

The commission received a request from the applicant who failed the physical agility portion of the original appointment testing asking for a further explanation. The applicant was in attendance at the meeting to make a formal request for review. He felt that according to the written instructions he did not fail for disqualification. He was instructed that he will be notified when a decision is made. After further discussion, the commission requested an explanation in writing from each of the proctors involved be submitted to them for review. The applicant will also be given the opportunity to submit an explanation in writing. These will be reviewed at a special meeting prior to a final decision being made regarding this matter.

It was noted that candidates #14 and #15 on the upcoming fire department original appointment eligibility list have the same score for each portion of the process. For the final list they will both be ranked as #14. In accordance with the City of Pekin Fire and Police Commission Rules and Regulations, Chapter III, Section 9.9.2, a lot will be determined at the time of a vacancy.
