Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

If using Project-Based Vouchers (PBVs), provide the projected number of project-based units and general locations, and describe how project basing would be consistent with the PHA Plan.</p> <p>The HAPB received an award of \$3,500,000 from Broward County Board of County Commissioners for the new construction of 100 senior units known as Provident Place on a 4.34 acres vacant parcel owned by the HAPB (known as Golden Acres) and funded through USDA. Through a competitive RFP process, the HAPB awarded up to 80 Section 8 Project-Based Vouchers for this new construction. The Housing Authority will apply for tax credits and other opportunities to fund this development. This activity is consistent with the Five-Year Plan as it expands the supply of assisted housing through PBV.</p> <p>The HAPB is also exploring additional options to expand housing opportunities and increase the affordable housing inventory in its community, including, but not limited to: purchasing and building affordable multi-family rental; utilizing its Faircloth of 113 units to RAD; PBV options; and creating homeownership opportunities.</p> <p>The HAPB is taking the opportunity provided by Section 22 of the Housing Act to maintain development affordability for the long term, through the conversion of Public Housing subsidy to Project Based Vouchers for the remaining Public Housing Units at Ben Turner. The HAPB will undertake the Voluntary Conversion process of converting its five (5) Public Housing units to the HCV Section 8 funding platform. The Public Housing units are a part of the HAPB's Ben Turner Ridge Apartment development, which was recently constructed in 2017, with a DOFA date of April 30, 2018. This Voluntary Conversion is consistent with the HAPB's mission of assuring fiscal integrity through the increase in revenue resulting from the fair market rents. The Voluntary Conversion is also consistent the HAPB's mission because it ensures funding is in place for long term viability of the building through preventative maintenance, thereby promoting decent, safe, sanitary, suitable living for its residents at an affordable rent. Moreover, Voluntary Conversion is consistent with the HAPB's goals to increase housing assisted housing choices and expand the supply of assisted housing. Finally, Voluntary Conversion is also consistent with HUD's intent to dramatically reduce its Public Housing stock.</p>

<p>B.3</p>	<p>Progress Report.</p> <p>Provide a description of the PHA’s progress in meeting its Mission and Goals described in the PHA 5-Year Plan.</p> <p>The Housing Authority of Pompano Beach is meeting the goals and objectives of the 5 Year Plan.</p> <p>As rents began to skyrocket the last quarter of 2022, the HAPB implemented a temporary Landlord Incentive Program Signing Bonus of \$1,500 to encourage landlords to rent to its HCV participants. We also applied for the Expedited Pandemic Regulatory Waiver Request in April of 2022 to allow for the establishment of payment standards from 111 to 120 percent of the FMR. This request was made to reduce the potential negative impact on tenants who are rent burdened due to rent increases, help families find housing outside of high poverty areas, increase housing options for families, increase lease-up times and increase lease-up success rates. Furthermore, we have continued to maintain affordable rents in a high rent market to ensure housing stability for our clients through our tax credit and market rate properties. We were able to utilize additional resources and employ strategies that have the biggest impact on increasing our clients’ affordable housing choices, including, but not limited to, working with and promoting Emergency Rental Assistance Programs (ERAP) available through the County, State and Local Governments to ensure that our families obtain and maintain a stable home, despite the impacts of COVID-19. Most recently, the HAPB partnered with the Family Success Center to assist its HCV families with security deposits.</p> <p>The afore-stated efforts exhibit the HAPB’s progress in meeting its mission and goals of expanding the supply of assisted housing, increasing assisted housing choices, providing an improved living environment, among other goals.</p> <p>The aim of the Housing Authority is to ensure safe, decent and affordable housing; create opportunities for residents’ self-sufficiency and economic independence; and assure fiscal integrity in all programs.</p> <p>Additionally, in an effort to further its mission of providing affordable housing, in 2018 the Housing Authority, through its affiliate entity, began purchasing residential homes within its jurisdiction, rehabilitating/renovating the homes as needed, and renting them to families at an affordable rent. To date, five (5) single family homes have been purchased and will continue to purchase additional homes. Moreover, the Housing Authority will continue to explore Notices of Funding Opportunities in an effort to obtain vouchers to assist individuals/families.</p> <p>The Housing Authority recognizes the participants/resident as its ultimate customer. Therefore, the Housing Authority has become a strong advocate for its families in a rental market that has seen an unprecedented increase in rents. The Authority is continually trying to improve our management and service delivery efforts through oversight, assistance and selective intervention by highly skilled, diagnostic and result- oriented personnel. The Authority has created a problem-solving partnership with our residents, the community, and government leadership.</p>

Note: A PHA may request to change its fiscal year to better coordinate its planning with planning done under the Consolidated Plan process by State or local officials as applicable.

C.3 Civil Rights Certification/ Certification Listing Policies and Programs that the PHA has Revised since Submission of its Last Annual Plan. Provide a certification that the following plan elements have been revised, provided to the RAB for comment before implementation, approved by the PHA board, and made available for review and inspection by the public. This requirement is satisfied by completing and submitting form HUD-50077 ST-HCV-HP, *PHA Certifications of Compliance with PHA Plan, Civil Rights, and Related Laws and Regulations Including PHA Plan Elements that Have Changed*. Form HUD-50077-ST-HCV-HP, *PHA Certifications of Compliance with PHA Plan, Civil Rights, and Related Laws and Regulations Including PHA Plan Elements that Have Changed* must be submitted by the PHA as an electronic attachment to the PHA Plan. This includes all certifications relating to Civil Rights and related regulations. A PHA will be considered in compliance with the certification requirement to affirmatively further fair housing if the PHA fulfills the requirements of §§ 903.7(o)(1) and 903.15(d) and: (i) examines its programs or proposed programs; (ii) identifies any fair housing issues and contributing factors within those programs, in accordance with 24 CFR 5.154; or 24 CFR 5.160(a)(3) as applicable (iii) specifies actions and strategies designed to address contributing factors, related fair housing issues, and goals in the applicable Assessment of Fair Housing consistent with 24 CFR 5.154 in a reasonable manner in view of the resources available; (iv) works with jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement; (v) operates programs in a manner consistent with any applicable consolidated plan under 24 CFR part 91, and with any order or agreement, to comply with the authorities specified in paragraph (o)(1) of this section; (vi) complies with any contribution or consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations. impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction's initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. (24 CFR §903.7(o)).

C.4 Challenged Elements. If any element of the Annual PHA Plan or 5-Year PHA Plan is challenged, a PHA must include such information as an attachment to the Annual PHA Plan or 5-Year PHA Plan with a description of any challenges to Plan elements, the source of the challenge, and the PHA's response to the public.

D. Affirmatively Furthering Fair Housing.

D.1 Affirmatively Furthering Fair Housing.

The PHA will use the answer blocks in item D.1 to provide a statement of its strategies and actions to implement each fair housing goal outlined in its accepted Assessment of Fair Housing (AFH) consistent with 24 CFR § 5.154(d)(5) that states, in relevant part: "To implement goals and priorities in an AFH, strategies and actions shall be included in program participants' ... Until such time as the PHA is required to submit an AFH, the PHA will not have to complete section D., nevertheless, the PHA will address its obligation to affirmatively further fair housing by fulfilling the requirements at 24 CFR 903.7(o)(3) enacted prior to August 17, 2015, which means that it examines its own programs or proposed programs; identifies any impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in

view of the resources available; works with local jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement; and maintain records reflecting these analyses and actions. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.

This information collection is authorized by Section 511 of the Quality Housing and Work Responsibility Act, which added a new section 5A to the U.S. Housing Act of 1937, as amended, which introduced the 5-Year and Annual PHA Plan. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Public reporting burden for this information collection is estimated to average 7.02 hours per response, including the time for reviewing instructions, searching existing data sources, gathering and maintaining the data needed, and completing and reviewing the collection of information. HUD may not collect this information, and respondents are not required to complete this form, unless it displays a currently valid OMB Control Number.
