Mr. Johnson presented the agreement with Johnsen Corrosion to service our five water towers. This maintenance program is required by state regulations. The three-year renewal contract of \$11,056.00 is the same as previous years. Mayor Meininger added that we cooperate with other communities in the area, which provides a decrease in the cost. Public Works Director Bohl added that they will schedule the painting of the water towers to coordinate with the cleaning. Moved by Council Member Colwell, seconded by Council Member McCarthy, "to approve the renewal of an Agreement with Johnsen Corrosion Engineering for continuing our existing Water Tower Corrosion Control Service Program and authorize the Mayor to execute the agreement," "YEAS", Colwell, Meininger, McCarthy, "NAYS", None. Absent: Gonzales, Shaver.

Mr. Johnson presented the Economic Development Assistance Grant for Vista Beam, clarifying that the application includes a \$100,000.00 grant and a \$50,000.00 loan. Mr. Matt Larsen, owner of Inventive Wireless / Vista Beam of Nebraska, informed the Council that they are the largest wireless broadband in the area. This grant would help them grow to 27 employees, which is three times what they were 4-5 years ago. They have had several LB 840 grants, and met all terms and continue to build their service in

Colorado, Wyoming and Nebraska. All jobs provide benefits as required in the grant. Council Member McCarthy asked how our area compares to others regarding wireless service. Mr. Larsen responded that we have better services than much of the country, with many wireless choices and wide spread fiber optics, including work by Action Communications and Allo. Mayor Meininger commended Mr. Larsen on submitting his LB840 grant applications, as the intent of the program is to grow businesses, as he has done over the years. Moved by Mayor Meininger, seconded by Council Member McCarthy, "to approve the LB840 Economic Development Assistance grant for Inventive Wireless / Vista Beam," "YEAS", Colwell, Meininger, McCarthy, "NAYS", None. Absent: Gonzales, Shaver.

Mr. Johnson explained that one of his goals is to work on the ISO rating for property owners in the City of Scottsbluff. He provided information regarding an opportunity to apply for a Public Safety Training Facility grant. There are several public and private providers for this type of a facility. There is Assistance to Firefighters Grant opportunity with NEMA through FEMA; the application process should be opening in the next few days. Mr. Johnson would like Council input to see if there is interest in applying for this type of facility. The system similar to the one in Grand Island is approximately \$656,000.00 and requires a 10% match from the City. We have \$70,000.00 budgeted for these matching funds if the Council wants to pursue the application.

Mayor Meininger asked what the rating would be to expand our ISO benefit. Mr. Johnson commented that our current rating is ISO 3. With this type of training facility, we could possibly be rated ISO 2, of which the potential offset of savings would be very significant, especially for large properties.

Mr. Johnson said the goal is to partnership with neighboring communities and create a regional educational facility, possibly at Western Nebraska Community College for all communities to use for training. Mayor Meininger added that there is an additional spin-off of holding regional training in our community, which benefits the economy of the area. Mr. Johnson also talked about the importance of having Firefighter I and Firefighter II training for recruiting for our Fire Department. This type of training facility would also benefit Emergency Medical Services and the Police Department. This facility would complement the existing facility located in Gering. Moved by Mayor Meininger, seconded by Council Member Colwell, "to pursue the application for a Public Safety Training Facility grant from the Nebraska Emergency Management Agency," "YEAS", Colwell, Meininger, McCarthy, "NAYS", None. Absent: Gonzales, Shaver.

City Manager Johnson discussed the recent issues regarding the League of Nebraska Municipalities (LONM) and the League Association of Risk Managers (LARM), beginning with a brief history of our relationship with LARM, since approving an Inter-local Agreement in 2003. In 2013, the By Laws were amended with the Executive Director centralization of the administrative responsibility of all affairs of LARM that are under the direction of the League Executive Director, Lynn Rex and the LARM Board.

LARM held a Board meeting on September 27, 2017, of which the City of Scottsbluff was not aware of until a few weeks ago. Some of the actions taken at that meeting were potential violations of the Inter-local Agreement and could potentially put the City of Scottsbluff at risk of not having insurance.

Some of the items voted on during this meeting were to designate LARM as a separate non-profit; establish LARM as the trade name; determine the Inter-local as a nullity; establish new sponsorship agreement with LONM; negotiate 2% decrease between LARM and the LONM; establish the LARM Board as the Administrator; rewrite the By Laws; and draft a written lease for the office space (the Inter-local identifies the location of the LARM office).

Mr. Johnson informed the Council that we originally joined LARM because of problems getting insurance and availability of the re-insurance carrier. The League of Nebraska Municipalities provides the re-insurance through our affiliation with the League. If LARM is no longer associated with LONM, this may jeopardize our ability to retain our re-insurance, which is a big concern.

At a recent LARM meeting, public comments from member cities were not accepted. We had sent a letter to LARM expressing our concerns as the largest city in the insurance pool, asking that it be included in the minutes. The LARM Board did not read the letter into the minutes; however, they acknowledged receipt of the letter. Mr. Johnson voiced his concern that one of the main advantages of being a member of LARM, is access to re-insurance.

Mayor Meininger expressed his concern over the 5 - 7 vacancies on the LARM Board, of which the Council has not been included in the process of filling these positions. Mr. Johnson's opinion of why we have not been asked to serve on this board is because we are the largest community in the insurance pool. Recently the LARM Board has not solicited Board Members from the entire membership.

City Attorney Kent Hadenfeldt informed the Council that we shouldn't take a position now, as the attorneys are involved and are currently talking about negotiating between LARM and LONM. The relationship is strained between the directors of LARM and LONM. This may not be the right time to take a position. Mayor Meininger voiced his concern about making sure that the City of Scottsbluff is protected, the taxpayer's money spent to provide insurance to the City of Scottsbluff is being managed properly, and we have a voice.

Mr. Johnson informed the Council that the premium to LARM was recently paid, and we signed a multi-year agreement, which concerns him if the Inter-local agreement is nullified.

City Attorney Hadenfeldt informed the Council that if we have to withdraw, there are notices that need to be filed. The National League of Cities requires an Inter-local between LARM and LONM to get the reinsurance. Mayor Meininger noted that it appears LARM has not been transparent. Council Member Colwell asked if there was LARM representation in Western Nebraska. Mr. Johnson informed him that Lane Danielzuk, Gering City Manager, is a Board Member, and has voted in favor of separating from LONM.

The Council directed City Manager Johnson to get more information and more facts regarding the relationship between the League of Nebraska Municipalities (LONM) and the League Association of Risk Managers (LARM) and report back to the Council.

At 6:35 p.m. Mayor Meininger moved, Council Member Colwell seconded, "to adjourn to closed session to protect the public interest for the purpose of discussing and developing strategy on the potential purchase of property for the purpose of developing a landfill site with the City of Gering," "YEAS", Colwell, Meininger, McCarthy, "NAYS", None. Absent: Gonzales, Shaver.

Mayor Meininger stated that the City Council is adjourning to closed session to protect the public interest for the purpose of discussing and developing strategy on the potential purchase of property for the purpose of developing a landfill site with the City of Gering.

At 6:55 p.m., Mayor Meininger moved, Council Member McCarthy seconded, "to reconvene out of closed session into regular session," "YEAS", Colwell, Meininger, McCarthy, "NAYS", None. Absent: Gonzales, Shaver.

Moved by Mayor Meininger, seconded by Council Member Colwell, "to continue to work with the City of Gering as equal partners in the potential purchase of property for the purpose of developing a landfill site," "YEAS", Colwell, Meininger, McCarthy, "NAYS", None. Absent: Gonzales, Shaver.

Under Council Reports, Mayor Meininger recognized the work of Council Member Colwell and Starr Lehl in helping get the bid for the National Balloon Race, which will be in our area for three years. This will have a significant economic impact in our area. Mayor Meininger thanked the City staff for the work they have done this past year and wished everyone a Happy Holiday.

Moved by Council Member McCarthy, seconded by Council Member Colwell, "to adjourn the meeting at 6:58 p.m.," "YEAS", Colwell, Meininger, McCarthy, "NAYS", None. Absent: Gonzales, Shaver.

A closed committee will evaluate the qualifications. The Cities of Scottsbluff and Gering reserve the right to reject any or all qualifications and to waive any informalities or technicalities.

1. QUALIFICATION STATEMENT

Firms are invited to submit a Qualification Statement that presents its experience, personnel, and references related to the siting, development, permitting, and design of landfill facilities. Qualification Statements shall include:

Include a positive commitment to complete the work with an estimated time period to meet permitting approval with NDEQ, and explain why the respondent should be selected in no more than three pages. The Evaluation Committee's objective is to select the highest qualified firm for the services to be rendered, at a compensation determined as fair and reasonable to the Cities. To accomplish this objective, respondents will be evaluated on the following basis:

Project Proposal: Respondents must provide a project proposal, which is in accordance with the information provided in this RFQ/RFP. Respondent proposals must include the following elements:

Siting, Development, Permitting, and Design of a New Landfill

Step 1: Site Assessment/Investigation

Step 2: Permit Development

Step 3: Final Design and Construction

1. STEP 1: SITE ASSESSMENT/INVESTIGATION

Step 1 involves landfill site assessment. There are ten (10) tasks involved which include surveying, geotechnical investigations, and specific studies that are pertinent and required to meet NDEQ regulations.

<u>Task 1</u> – Preliminary Geotechnical Investigations: Investigations and studies shall be performed to determine whether the site selected by the City meets all Federal, State, and Local permitting requirements specifically NDEQ and Scotts Bluff County for a new Municipal Solid Waste (MSW) Landfill and Construction and Demolition (C&D) site. In the event the site does not meet said requirements the firm would assist the City to locate a suitable site meeting NDEQ and County permitting requirements.

<u>Task 2</u> - Site Survey: The surveying work will include detailed topography using GPS of the entire site to obtain a base map and topographic maps to be utilized for the project meeting NDEQ mapping requirements. Mapping shall include survey control with all monumentation and reference points with Northing and Easting labeled and shown on the maps. The contours of the map will have an accuracy of ± 0.4 feet. The topographical survey will be tied to the Nebraska State Plane Coordinate System and the survey and design information will be prepared for the City in dwg format for use with AutoCAD Civil 3D.

<u>Task 3</u> - Geotechnical Work: Investigations will be performed to determine: (1) the hydrogeological setting and characteristics of the site; (2) a review of the characterization of the vadose zone (if applicable) and documentation meeting NDEQ locational and design permitting criteria to operate a MSW landfill and C&D site; and (3) a liner and cover alternative analysis. These studies will be conducted to meet the NDEQ permitting requirements and to establish a complete data base for the landfill design.

<u>Task 4</u> - Surface Drainage Analysis: This analysis will evaluate both existing and final drainage conditions for the landfill site and access road(s) and will meet and/or exceed all NDEQ requirements.

- <u>Task 5</u> Archaeological Survey and Threatened and Endangered Species: Perform an environmental review per NDEQ requirements to meet permitting requirements for a MSW landfill and C&D site. This will include a threatened and endangered species survey of the proposed landfill site. Conduct an initial background search on information on state and federally listed species and critical habitats that may occur in Scotts Bluff County. A pedestrian survey to map vegetative types, determine the presence or absence of critical habitat suitable for listed species, and to verify as accurately as possible the presence or absence of any listed flora or fauna will be performed to address the regulatory concerns of NDEQ.
- <u>Task 6</u> Seismic Impact Zones: Seismic documentation per Title 132, Chapter 3, <u>002.09</u> at the site will be performed to meet NDEQ requirements.
- <u>Task 7</u> Preliminary Conceptual Design: Engineer will prepare a preliminary design for the site. This design will identify the parameters of the site and the requirements for the facility design. The preliminary design will identify building locations, fence lines, cell geometry, storm water channels, borrow sources, utilities, access roads, liner requirements, and all other ancillary facilities necessary for the development of the landfill for a minimum landfill design life of 75 years.
- <u>Task 8</u> Preliminary Cost Estimate: Engineer will prepare a preliminary cost estimate. This estimate, based on the preliminary conceptual design, will involve developing a takeoff sheet to identify all items necessary to perform the surveying, siting, hydrogeological studies, permitting, and design/layout of cells. This estimate shall also include the design and permitting approval process of Cell 1 as shown on the Preliminary Conceptual Design (Task 7). This cost estimate will be utilized to identify potential problems, further refine the potential level of funding required, further refine specific requirements for the site, establish if funds are available, and identify additional items that may be added to the project.
- <u>Task 9</u> Preliminary Schedule using MS Project with Gantt Chart: Preliminary siting and permitting schedule showing all activities required to obtain approvals through initial landfill site selection, surveying, mapping, hydrogeological studies, installation of required monitoring wells, testing, reports, meetings including public informational meetings, and other pertinent elements required for a new MSWL. This schedule shall also include testing activities and design timeline necessary to obtain design approval/construction acceptance for Cell 1. This schedule will be utilized to identify critical paths during the siting and permitting phase and identify additional items that may be added to enable permitting.
- <u>Task 10</u> Meetings: Meetings with the Owner, Community, and others will be critical throughout the project. These meetings will be both formal and informal and will involve transmitting information and, most importantly, addressing concerns and issues that may have arisen during the step/tasks associated with the project.

2. STEP 2: PERMIT APPLICATION DEVELOPMENT

This step involves developing the permit application for the Municipal Solid Waste Landfill including con-current C&D Permitting (all tasks). There are eight (8) tasks in this step. At the completion of this step, the landfill permit application will be submitted to NDEQ and the public hearing process completed.

- <u>Task 1</u> Permit Drawings: Engineer will prepare permit design drawings for the landfill to be used in the permit application and for the final design. This design will be based on the results established and a minimum 50-year landfill permit life.
- <u>Task 2</u> Modeling and Analysis: Engineer will perform the modeling and analyses necessary to meet the requirements of NDEQ as related to groundwater protection and landfill liner design.
- <u>Task 3</u> Groundwater and Gas Monitoring Plans: Engineer will develop groundwater and gas monitoring plans per NDEQ requirements.
- <u>Task 4</u> Closure Plan: Engineer will prepare a Closure/Post-Closure Plan for the landfill area in accordance with the latest NDEQ Solid Waste Management Regulations. Engineer will prepare financial assurance estimates for closure and post-closure assessments. Engineer will assist in determining funding mechanisms to be used for financial assurance.
- <u>Task 5</u> Operations Plan: The operations plan will be developed to address specific requirements of NDEQ and it will be organized and prepared to be included in the NDEQ permit application.
- <u>Task 6</u> Assemble Permit Application Documents: All of the pertinent documents will be assembled into the permit application. The permit application will be prepared in accordance with the latest Nebraska Solid Waste Management Regulatory requirements.
- <u>Task 7</u> Public Hearings: Engineer will prepare for and conduct public hearings for the landfill permit. Engineer will include the Owner in all activities relating to required public hearings. Engineer will interact with NDEQ to identify the level of effort as related to the public hearings meeting NDEQ 13-1706 Public Hearing Processes.
- <u>Task 8</u> Meetings: Meetings with the Owner, Community, and others will be critical throughout the project. These meetings will be both formal and informal and will involve transmitting information and, most importantly, addressing concerns and issues that may have arisen during this step in the project.

3. STEP 3 FINAL DESIGN AND CONSTRUCTION

Step 3 will involve four (4) tasks. These tasks address the final design and construction of the municipal solid waste landfill. These tasks are prepared to be completed in series and will be implemented at the direction of the Owner.

- <u>Task 1</u>- Final Design: Once the permit application is accepted by NDEQ and the Owner gives its Notice to Proceed, Engineer will commence the final design process. Based on all previous work completed, Engineer will prepare final bidding documents, final drawings, and technical specifications. The drawings will include the complete MSWL and C&D site including structures and access' and all other work related to the construction of the first cell of the landfill.
- <u>Task 2</u> Final Cost Estimate: Engineer will prepare a final cost estimate. This estimate will be based on the final design.
- <u>Task 3</u> Construction Bidding Services: Engineer will provide complete bidding services. These services include preparing the bid advertisement, chairing the pre-bid conference, responding to contractor questions, preparing addenda, evaluating the bid submittal, and providing a recommendation of award.
- <u>Task 4</u> Construction Inspection Services: Engineer will provide construction inspection services the Owner may require for the construction of the first landfill cell meeting the CQA Plan. At a minimum, Engineer will be involved with the oversight of the installation including but not limited to: (1) the subgrade for the liner; (2) the liner; (3) the liner protection system; (4) inspection of the construction of the road work; (5) drainage system; (6) buildings; (7) and other ancillary facilities. Engineer shall establish an inspection procedure program to assist in the inspection process. All NDEQ requirements will be satisfied and the facility will meet all necessary regulations. Engineer shall provide all inspection services including testing, monitoring, and installation review.

4. STEP 4 PROJECT SCHEDULE

The project schedule shall be completed using MS Project with Gantt Chart Layout and reflect the steps and tasks presented in the Scope of Work.

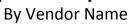

BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF SCOTTSBLUFF, NEBRASKA:

- 1. The public safety, health, convenience and welfare require that Handicapped Parking Spaces be established on the public streets pursuant to §22-6-47 of the Municipal Code.
- 2. The following public spaces on the public streets are hereby designated as handicapped parking spaces:

Broadway Avenue:

A portion of the east side of Broadway Avenue, two diagonal parking spaces, beginning at a point which is 16 feet south of the south curb line of East 16th Street. There shall then be two handicapped parking spaces immediately south of that point, each 9 feet wide with a 5 foot access aisle between the two spaces.

A portion of the east side of Broadway beginning 40 feet south of East 16th street curb line, two diagonal parking spaces designated handicap parking with an access lane in between continuing for a distance of 55 feet.

A portion of the west side of Broadway beginning 55 feet south of West 17th street curb line, two diagonal parking spaces designated handicap parking with an access lane in between continuing for a distance of 55 feet.

A portion of the east side of Broadway beginning 55 feet south of the East 18th street curb line, two diagonal parking spaces designated handicap parking with an access lane in between continuing for a distance of 55 feet.

First Avenue:

The first parallel parking space immediately south of 16th Street on the west side of First Avenue, (begins 29 feet south of the south curb line of East 16th Street). The space shall be 8 feet in width and 22 feet in length.

First Avenue

The first parallel parking space immediately south of 17th Street on the west side of First Avenue, beginning 45 feet south of the south curb line of 17th Street.

Fourth Avenue:

The 36 feet of parking space on the east side of Fourth Avenue commencing 84 feet north of the north curb line of East 19th Street.

Ninth Avenue:

The 45 feet of parking space on the west side of Ninth Avenue commencing 188 feet north of the north curb line of East Overland.

Twenty-first Avenue:

At 1502 21st Avenue: Starting 8 feet south and 2 feet west from the Southeast corner of the building continuing west 84 feet.

Avenue A:

The first 38 feet of parking space commencing 107 feet north of West 21st Street on the west side of Avenue A.

East 11th Street:

Beginning on the north side of East 11th Street and 30' west of the west curb line of 12th Avenue and continuing 53'6" west of the west curb line of the intersection of East 11th Street and 12th Avenue, adjacent to the handicap ramp located on the sidewalk near that intersection.

East 14th Street:

Two stalls 20 feet long by 10 feet wide, starting 30 feet west of 12th Avenue on East 14th Street.

East 15th Street:

The fourth parallel parking space west of First Avenue on the north side of 15th Street between Broadway and First Avenue.

West 15th Street:

The first 25 feet of parking space on the north side of West 15th Street commencing 35 feet east of the east curb line of Avenue F.

East 16th Street:

The first parallel parking space immediately west of the alley on the north side of East 16th Street between Broadway and First Avenue.

West 16th Street:

The fifth parallel parking space west of Broadway Avenue on the south side of 16th Street commencing 131 feet west of the west curb line of Broadway.

East 19th Street:

The third parallel parking space immediately west of First Avenue on the north side of 19th Street commencing 68 feet west of the west curb line of First Avenue.

East 21st Street:

The 46 feet of parking space on the south side of East 21st Street commencing 107 feet east of the east curb line of Fifth Avenue.

Avenue K:

The first two parking spaces on the west side of Avenue K commencing along the curb line of West 18th Street as designated by signs posted above ground and immediately adjacent to the parking spaces and which parking spaces are indicated by blue paint adjacent to each parking space.

Cleveland Field:

The first two parking spaces on the concrete pad located immediately south of the admission building which are designated by signs posted above ground and immediately adjacent to the parking spaces and which parking spaces are indicated by blue paint adjacent to each parking space.

Avenue D:

The first four parking spaces on the west side of Avenue D along the north curb line of 31st Street as designated by signs posted above ground and immediately adjacent to the parking spaces and which parking spaces are indicated by blue paint adjacent to each parking space.

East 23rd Street:

The first six parking spaces along the west curb line of 3rd Avenue as designated by signs posted above ground and immediately adjacent to the parking spaces and which parking spaces are indicated by blue paint adjacent to each parking space.

City Hall:

The parking space located in the south corner of the parking lot immediately west of City Hall, as designated by signs posted above ground and immediately adjacent to the parking spaces and which parking spaces are indicated by blue paint adjacent to each parking space.

6th Avenue:

The first parking space on the west side of 6th Avenue along the north curb lien of East 15th Street, as designated by signs posted above ground and immediately adjacent to the parking spaces and which parking spaces are indicated by blue paint adjacent to each parking space.

West 16th Street:

The first parking space on the west of the alley on the north side of West 16th Street, as designated by signs posted above ground and immediately adjacent to the parking spaces and which parking spaces are indicated by blue paint adjacent to each parking space.

Police Station:

The southeast corner parking space beginning along the north curb line on West 18th Street, as designated by signs posted above ground and immediately adjacent to the parking spaces and which parking spaces are indicated by blue paint adjacent to each parking space.

- 3. Resolution No. 15-08-05 and all other resolutions in conflict with this Resolution are repealed to the extent that an actual conflict with this Resolution exists.

Council to consider approval of the Economic Development Assistance Grant for Mitchell Care Center.

City of Scottsbluff Economic Development Application Review Committee December 22, 2017

A meeting of the Economic Development Application Review Committee was held on December 22, 2017, at 8:00 a.m. at City Hall, 2525 Circle Drive, Scottsbluff, NE.

The meeting was convened at 8:01 a.m. Present were Committee Members, Jim Trumbull, Dennis Hadden, Marla Marx, and Dave Schaff. In attendance on behalf of the City were Program Administrator, Nathan Johnson, Deputy City Attorney, Rick Ediger, City Economic Development Director, Starr Lehl, and City Finance Director, Liz Hilyard.

Chairman Trumbull called the meeting to order and stated that a copy of the Nebraska Open Meetings Act is located on the South wall of the Council Chamber. Item 6 was removed from the Agenda. There were no other changes in the Agenda, nor were there any citizens with business not scheduled on the Agenda.

It was moved by Hadden and seconded by Marx that the Minutes of the December 8, 2017 Committee Meeting be approved. Voting yes: Trumbull, Hadden, Marx, and Schaff. Voting no: None.

An Application for Assistance from Lamp Public Relations & Marketing, LLC was presented. Present on behalf of the Applicant was Jody Lamp, President of the Applicant. Also present in support of the Applicant was Kevin Kelley. The Applicant is requesting support for a project which has been titled "Legacy Project 2019". Funds will be used with respect to a commemorative documentary film project, along with an educational "Circle Tour" booklet. Specifically, the project will honor and commemorate the upbringing and life of John A. Nerud. Mr. Nerud was born near Lake Minatare and was a 1931 Minatare High School graduate. He was known to be one of America's most accomplished and revered thoroughbred horse trainers and breeders. The Applicant has already received funding from several local businesses and a grant from Nebraska Humanities Council. It was indicated that the City does not currently have the production of films as an eligible activity under its Economic Development Plan. However, this type of activity can be added by the Plan upon recommendation of the Citizen Advisory Review Committee and approval by the City Council. The Members present indicated they would generally be supportive of a grant to the project if the production of films is added to the City's Economic Development Program. City staff will pursue consideration of the addition of film production to the City's Economic Development Plan.

Consideration of the Application of Mitchell Health Center, Inc. ("MHC") had previously been tabled by the Committee. It was moved by Schaff and seconded by Marx to remove this matter from the table. Voting yes: Trumbull, Hadden, Marx, and Schaff. Voting no: None. Since the December 8th meeting, the Application had been amended to add Rural Health Development, Inc. ("RHD") as a Co-Applicant. In addition, a spreadsheet was presented which showed the proposed

flow of funds. Following additional discussion, it was moved by Schaff and seconded by Marx that a grant be awarded to the Applicants in the amount of \$306,400, to be paid at the rate of \$6,383.33 monthly, retroactive to September 2017. Payments would continue for a total of four years. The Grant is contingent upon the City of Mitchell renegotiating its agreement with RHD. In addition, RHD must maintain all required licensing, continue to be accredited for Medicare and Medicaid patients, and not be in default with the City of Mitchell with their agreement to operate the Mitchell Health Center. Voting yes: Trumbull, Hadden, Marx, and Schaff. Voting no: None.

Due to prior commitments of Committee Members, discussion regarding the Gering Industrial Park Agreement will be postponed to a later meeting.

City Manager Johnson indicated that the reason why the Application for Pioneer Animal Health Clinic was removed from the Agenda was due to the fact that all but two of the Committee Members had conflicts of interest. As a result, there would not have been sufficient votes to make a recommendation. The Committee currently has one alternate (Dave Schaff) and has a vacancy for a second alternate. The City Manager invited Committee Members to make suggestions as to individuals to fill that alternate position. The plan is to nominate an additional alternate to be approved at the City Council's January 2nd meeting. Once the alternate is approved, this Application will be placed on the Agenda of a future meeting.

ECONOMIC DEVELOPMENT ASSISTANCE AGREEMENT

This Agreement is made on January ____, 2018, between the City of Scottsbluff, Nebraska (the "City") and Rural Health Development, Inc. and Mitchell Health Care, Inc. (the "Applicants").

Recitals:

- a. The City has adopted an Economic Development Plan pursuant to the Nebraska Local Option Municipal Economic Development Act (the "Plan"). Pursuant to the Plan, the City has implemented an Economic Development Program (the "Program").
- b. The Applicants have made application for assistance from the Program (the "Application");
- c. The Administrator of the Program (the "Administrator") and the City Council (the "Council") have reviewed the Application. The Council has determined that a grant (the "Grant") be awarded to the Applicants from the City of Scottsbluff Economic Development Fund (the "Fund") as provided for in this Agreement.
- d. The parties now desire to enter into this Agreement for the purpose of setting out the terms and conditions of the Grant.

Agreement:

1. Purpose of Grant and Application of Funds:

- a. The Applicants operate and provide services under contract to the City of Mitchell for the operation of the Mitchell Care Center (the "Center"). The Center serves residents from western Nebraska and neighboring states.
- b. The Grant will be used to provide funding to pay management fees, job training and technical assistance, as provided for in the revised Application.

2. Amount of Grant:

The amount of the Grant awarded to the Applicants is \$306,400. The Grant shall be payable from the Fund at the rate of \$6,383.33 per month retroactive to September 2017, as follows:

a. \$38,300 shall be payable at the Closing (the "Closing Payment"). The Closing Payment represents payments for the 6 month period from September 2017 through February 2018.

b. All future monthly payments (each, an "Additional Payment") shall be paid on or before the 15th day of each month beginning March 2018 and ending in August 2021.

3. Closing:

As soon as the Applicants have satisfied the conditions to the Closing, the Closing Payment shall be scheduled as a claim at the next Council meeting for which the matter may be reasonably scheduled. The Closing, to include delivery of the Closing payment, shall then occur within 10 business days after the Council has approved the claim for the Closing Payment.

4. Representations and Warranties of the Applicant:

The Applicants represent and warrant the following, all of which shall survive the Closing:

- a. The Applicants are corporations organized, existing, and in good standing under the laws of Nebraska. The Applicants have full power and authority to enter into this Agreement and carry out the transactions contemplated by this Agreement. The Applicants' execution, delivery and performance of this Agreement have been authorized by all necessary action on the part of the Applicants. This Agreement, and each agreement and instrument delivered by the Applicants pursuant to it, is the legal and binding obligation of the Applicants, enforceable against the Applicants in accordance with its terms.
- b. No representation or warranty made by the Applicants in this Agreement contains or will contain any untrue statement of any material fact, or omits or will fail to state any material fact known to the Applicants that are required to make the statements not misleading.
- c. The execution and performance of this Agreement will not violate any provision of law, or conflict with or result in any breach of any of the terms or conditions of, or constitute a default under any indenture, mortgage, agreement or other instrument to which the Applicants are a party or by which they are bound.

All representations and warranties made by the Applicants shall survive the Closing.

5. Representations and Warranties of the City:

The City represents and warrants the following, all of which shall survive the Closing:

a. The City is a municipal corporation organized and existing under the laws of Nebraska, and has full power and authority to enter into this Agreement and carry out the transactions contemplated by this Agreement. The City's execution, delivery and performance of this Agreement has been authorized by all necessary action on the part of the City. This Agreement, and each agreement and instrument delivered by the City pursuant to it, is the legal and binding obligation of the City, enforceable against the City in accordance with its terms.

b. No representation or warranty made by the City in this Agreement contains or will contain any untrue statement of any material fact, or omits or will fail to state any material fact known to the City that is required to make the statements not misleading.

6. Certification of the Applicant:

The Applicants certify to the City that they have not filed nor do they intend to file an application with the Department of Revenue to receive tax incentives under the Nebraska Advantage Act for the Center.

7. Conditions to Closing:

The City's obligation to proceed with the Closing is subject to the Applicant's fulfillment of each of the following conditions at or prior to the Closing:

- a. All representations and warranties of the Applicants shall be true as of the Closing.
 - b. The Applicants shall have delivered to the City:
 - (1) Evidence of Good Standing of the Applicants from the Nebraska Secretary of State.
 - (2) A copy of the current and correct Articles of Incorporation and Bylaws of the Applicants certified by their respective secretaries to be correct;
 - (3) Certified resolutions of the directors of the Applicants authorizing the Applicants entering into this Agreement and providing for signature authority.
- c. Rural Health Development, Inc. shall have entered into a new or amended Agreement with the City concerning the operation of the Center.
- d. The Applicants shall in all material respects have performed their obligations, agreements, and covenants contained in this Agreement to be performed by them, on, or before the Closing.
- e. There shall have been no material adverse change in the operation or financial status of the Applicants and the Closing shall constitute the Applicant's representations that there has been no such material adverse change.
- f. In accepting each Additional Payment under this Agreement, the Applicants are considered to have represented that the above conditions have been satisfied and are continuing to be satisfied.

8. Early Termination:

- a. Both Applicants acting together shall have the right at any time to terminate their participation in the Program by notifying the Administrator in writing of their desire to do so.
- b. The Administrator shall have the right to terminate the Applicants' participation in the Program if the Applicants are in default of any of the terms and conditions of this Agreement, which default is not cured within 30 days of written notice by the Administrator.
- c. In the event of a termination as described in this paragraph, then the Applicants shall have no further right to receive Additional Payments.

9. Default:

The Applicants shall be in default if any of the following happen:

- a. Failure to comply with any of the terms of this Agreement to include an assignment not permitted under this Agreement.
- b. Any warranty, representation or statement made or given to the City by the Applicants proves to have been false in any material respect when made or given.
- c. Dissolution or liquidation of any the Applicants, the termination of existence, insolvency, business failure, appointment of a receiver, assignment for the benefit of creditors, or bankruptcy of the Applicant.
- d. Rural Health Development, Inc. ceases to operate the Center, is no longer licensed to operate the Center, or is no longer eligible to receive payment for Medicare and/or Medicaid patients.
- e. Either of the Applicants are in default in their agreements with the City of Mitchell.

10. Assignability:

The Administrator may assign his interest in this Agreement to any successor administrator designated by the City Council. The Applicants may not assign or transfer their interest in this Agreement without the consent of the Administrator. Assignment shall include a transfer of stock of the Applicants so that Ron Ross does not own at least 51% of the stock of either or both Applicants

11. Confidentiality:

It is agreed that this Agreement and its terms are public record and are not confidential. However, the City agrees to take reasonable steps to insure that any financial and proprietary

information provided in connection with this Agreement by the Applicant shall remain confidential and shall not be revealed or disclosed to outside sources unless the information is public knowledge, is independently developed, or is required to be disclosed by law or legal process.

12. Notices:

Any notices or other communications between the parties shall be personally delivered, sent by certified or registered mail, return receipt requested, by Federal Express or similar service that records delivery, or by email transmission combined with any of the above methods of notice, to the addresses set out below, or to such other address as a party may designate, from time to time, by written notice to the other. A notice shall be deemed effective upon receipt.

13. Miscellaneous:

a. This Agreement constitutes the entire agreement of the parties with respect to its subject matter, and may only be modified by a writing signed by both of the parties.

- b. The City's waiver of any one default shall not be a waiver of the same or any other default in the future. In addition, the City's failure to exercise any right given to it by this Agreement shall not be a waiver of any later exercise of that right.
- c. The provisions of this Agreement are severable and if any provision is held to be invalid, the remainder of the Agreement shall remain in effect.
- d. This Agreement may be executed in any number of counterparts, each of which shall be deemed an original, but which together shall constitute a single instrument.
 - e. This Agreement shall be governed by the laws of Nebraska.
 - f. This Agreement shall be binding on the successors and assigns of the parties.
