ORDINANCE 994

AN ORDINANCE ADOPTING THE
2018 INTERNATIONAL SWIMMING POOL AND SPA CODE
AND AMENDING THE CITY OF STRAFFORD, MISSOURI MUNICIPAL CODE,
TITLE V BUILDING AND CONSTRUCTION BY REPEALING ARTICLE II-A, ICC
PERFORMANCE CODE SECTIONS 500.102 AND 500.104 IN THEIR ENTIRETY,
AND ENACTING IN LIEU THEREOF A NEW ARTICLE II-A,
SWIMMING POOL AND SPA CODE, SECTION 500.102

WHEREAS the City of Strafford wishes to adopt the 2018 Edition of the International Swimming Pool and Spa Code. Now therefore, be ordained by the Board of Aldermen of the City of Strafford, Missouri, as follows:

AMENDING the City of Strafford, Missouri Municipal Code, Title V Building and Construction by repealing Article II-A, ICC Performance Code, Sections 500.102 and 500.104 in their entirety, and enacting in lieu thereof a new Article II-A, Swimming Pool and Spa Code, Section 500.102

Adoption of 2018 International Swimming Pool and Spa Code. The Board of Aldermen hereby adopts the 2018 International Swimming Pool and Spa Code, as published by the International Code Council, and all referenced standards therein as if spelled out in this Ordinance, except such portions thereof as are hereinafter deleted, modified, or amended. This code shall be designated as Section 500.102 Swimming Pool and Spa Code of Title V Building and Construction known as part of the Strafford Municipal Code. One (1) copy of said code is on file in the office of the City Clerk, City Hall 126 South Washington Avenue, Strafford, Missouri. The 2018 International Swimming Pool and Spa Code, as adopted, is hereby amended, and changed as follows.
