AN ORDINANCE REPEALING CHAPTER 1 – ADMINISTRATION, ARTICLE IV – FINANCIAL AND ADDING IT TO CHAPTER 22 – MANDATED POLICIES, ARTICLE III OF THE REVISED CODE OF ORDINANCES OF THE CITY OF SULLIVAN, MOULTRIE COUNTY, ILLINOIS

WHEREAS, the City of Sullivan, Moultrie County, Illinois, is a duly established and functioning municipal corporation; and

WHEREAS, on May 23, 2022, the City of Sullivan passed Ordinance 22-13 establishing an investment policy for the City of Sullivan

BE IT ORDAINED by the Mayor and City Council of the City of Sullivan, Moultrie County, Illinois, that:

Section 1: That Article IV – Financial shall be removed from Chapter 1, Administration

Section 2: The language removed from Chapter 1, Article IV – Financial shall then be added to Chapter 22, Mandated Policies - Article III – Investment Policy

Section 2: All previous ordinances in conflict with this ordinance are repealed to the extent of such conflict.

Section 3: This Ordinance shall be in full force and effect immediately after its passage, approval, and publication in pamphlet form.
