ORDINANCE NO. 23-6
ORDINANCE AUTHORIZING DISPOSAL OF
PERSONAL PROPERTY OWNED BY THE CITY OF SULLIVAN

WHEREAS, in the opinion of the corporate authorities of the City of Sullivan, it is no longer necessary, useful, or in the best interests of the City to retain ownership of the personal property described in this ordinance; and

WHEREAS, it has been determined by the Mayor and City Council of the City to dispose of that personal property in the manner described in this ordinance;

NOW, BE IT ORDAINED by the City Council of the City of Sullivan, Moultrie County, Illinois, as follows:

SECTION 1: Recitals. The foregoing recitals are hereby incorporated into this ordinance as findings of the Mayor and City Council.

SECTION 2: Disposal of Personal Property. The Mayor and City Council find that the personal property described in Exhibit A attached to this Ordinance and by this reference incorporated into this Ordinance (surplus property) is no longer necessary or useful to the City and thus the City Clerk is hereby authorized to direct the sale or disposal of the surplus property in the manner most appropriate to the City. Surplus property must be sold or disposed of in "as is" condition.

SECTION 3: All previous ordinances in conflict with this ordinance are repealed to the extent of such conflict.

SECTION 4: This ordinance shall be known as Ordinance 23-6.

PASSED this 14th day of February, 2023, by the City Council of the City of Sullivan, Moultrie County, Illinois, and deposited and filed in the office of the City Clerk of said City on that date.
