ORDINANCE NO. 22-3

**AN ORDINANCE AMENDING CHAPTER 7 – BUSINESS CODE,  
SECTION 7-5-9 OF THE REVISED CODE OF ORDINANCES  
OF THE CITY OF SULLIVAN, ILLINOIS**

**BE IT ORDAINED** by the Mayor and City Council of the City of Sullivan, Moultrie County, Illinois, that:

**SECTION 1:** CHAPTER 7 – BUSINESS CODE, Section 7-5-9 shall be amended to read as follows:

**7-5-9 TERMS AND FEES.**

- (A) The aggregate retail value of all prizes or merchandise awarded by a licensee in a single raffle shall not exceed **five hundred thousand dollars (\$500,000.00)**;
- (B) The maximum retail value of each prize awarded by a licensee in a single raffle shall not exceed **five hundred thousand dollars (\$500,000.00)**;
- (C) The maximum price which may be charged for each raffle chance issued or sold shall not exceed **five hundred dollars (\$500.00)**;
- (D) The maximum number of days during which chances may be issued or sold shall not exceed **one hundred eighty (180) days**;
- (E) Licenses issued pursuant to this Article shall be valid for **one (1) raffle** and may be suspended or revoked for any violation of this Article;

**SECTION 2:** All previous ordinances in conflict with this ordinance are repealed to the extent of such conflict.

**SECTION 3:** This ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.


**SECTION 4:** This ordinance shall be known as Ordinance 22-3.
